## Lake Marion shoreline restoration project

The Lake Marion shoreline has been slowly eroding over the years, to the point where there are locations with vertical banks, undercutting of the shoreline and encroachment up to the walking path. Funding was included in the 2018 MVF Reserve Budget for lake bank restoration. This project has been in the design, review and permitting stage for the last year.

At the January 23 Montgomery Village Foundation (MVF) Board of Directors meeting, the Board awarded the construction contract for the shoreline stabilization project to Ecotone, Inc. Ecotone is an ecological restoration firm that provides

full delivery ecosystem restoration, mitigation, design and construction. They have done several stream and lake bank restoration projects for MVF in the past.

Ecotone has indicated that they will begin construction of the project around Monday, March 16. At that time, they will lower the lake level enough to expose the shoreline area in preparation for the repairs. The project should take approximately two weeks to complete.

## Watkins Mill Pool site moving forward as outdoor fitness space

Since planning for the 2020 Montgomery Village Foundation (MVF) Budget, the Watkins Mill Pool has been slated to be repurposed, given its low use and high operating, maintenance and reserve costs. Throughout 2019, discussion and input opportunities were

held, with feedback coming before the Recreation Committee in January.

In February, the committee met to further discuss fitness-based concepts for the site before making a recom-



February 27, 2020**

1. Mr. Dyer moved to approve the minutes of the regular meeting held January 23, 2020 as presented. The motion was seconded and passed (5-0-2); Mr. Davis and Ms. Bort abstained.
2. Mr. Dyer moved to accept the Action List as submitted. The motion was seconded and passed unanimously.
3. Mr. Dyer moved to appoint Clare Conlon as Chair (North Village), David Cline (East Village) and Sharon Levine (Whetstone) as the 2020 Scholarship Committee. The motion was seconded and passed unanimously.
4. Mr. Dyer moved to authorize proceeding with an RFP Phase I of engineering services for the repurpose of Watkins Mill pool to create the outdoor fitness space with exercise track and playground, including the developing of the concept plan, site plan, demolition plan and applying for any permits that the Department of Permitting Services requires. The motion was seconded and passed unanimously.
5. Mr. Young moved to award the bid to All Pro Recreational Surfaces for the repair and resurfacing of the Apple Ridge Recreation Area tennis court in the amount of \$22,400 with an additional 10% for any unforeseen expenses. The motion was seconded and passed unanimously.
6. Mr. Young moved to accept the proposed changes to the Procedures for the Private Use of Facilities to include adding Stedwick Community Center; increase in rental rates at specified facilities and allowance of light alcohol (as specified) at the North Creek Community Center with two (2) staff present and a certificate of insurance for the purchase of additional insurance naming MVF as an additional insured. The motion was seconded and unanimously approved.
7. Ms. Ayres moved to award the 2020 de-winterization of the MVF pools to High Sierra Pools, Inc for the total cost of \$18,000 plus time and materials. In addition, authorization is provided to contract with High Sierra Pools, Inc for the same pool maintenance services in the 2021 and 2022 if they perform favorably in 2020. The motion was seconded and unanimously approved.
8. Mr. Dyer moved to accept the committee reports. The motion was seconded and passed unanimously.
9. Mr. Dyer moved to adjourn the regular meeting at 7:55 p.m. pursuant to Section 11B Real Property, of the Annotated Code of Maryland (Maryland Homeowners Association Act) to go into closed session for (i) Discussion of matters pertaining to employees and personnel and (iii) Consultation with legal counsel on legal matters. The motion was seconded and passed unanimously.

## MONTGOMERY VILLAGE NEWS LETTERS TO THE EDITOR POLICY

1. The *Montgomery Village News* Letters to the Editor section is a community forum for Montgomery Village residents and/or property owners in the printed version of the *Village News*. In addition, at the Editor's discretion, the *Montgomery Village News* may print letters of appropriate interest to residents from others, including representatives of local schools, governments and businesses. Campaign letters are prohibited, except for Montgomery Village Foundation and Village homes corporation elections. The views expressed in the Letters to the Editor section are those of the authors of the letters and not necessarily those of the Montgomery Village Foundation (MVF) or its Board of Directors.

2. The *Montgomery Village News* will make every effort to publish all letters

received during the weeks prior to publication that meet the criteria of this policy.

3. All letters (typed, handwritten or e-mailed) must be received no later than 5 p.m. on the Monday prior to publication and distribution. When a holiday occurs on a deadline Monday, Letters to the Editor must be received no later than noon on the subsequent Tuesday prior to the Friday publication and distribution.

4. Letters must bear the writer's name, address and telephone number for verification purposes. E-mailed letters should contain the subject line "Letter to the Editor." The sole use of pen names, initials or the complete omission of a signature will eliminate a letter from consideration for publication. A request from the author to

withhold the name or mark the letter anonymous will eliminate the letter from consideration.

5. All letters are subject to condensation or deferral to the next issue by the editor for space considerations, if absolutely necessary. Editor is to so indicate any condensations.

6. **All letters may not exceed 350 words. Longer letters will be eliminated from consideration for publication in the *Village News*. As time permits, the writers may be notified and given the opportunity to shorten the letter for future publication.**

7. The *Village News* respects the privacy of individuals and residents; letters should not contain references to specific persons, except when endorsing candidates for MVF or Village homes corporation elections or referencing

a previously published article with a byline.

8. Letters submitted by an author regarding the same topic must present new information or opinions; repetitive submissions and/or form letters submissions will only be printed once.

# Letters to the Editor

Editor:  
The response to the February 7 MV News Letter to Editor by Ralph Colling, who wrote asking the MVF Board to change the current Condo Homeowner policy of paying MVF through their condo association, is telling. The EVP, (Editor's Note), stated that MVF staff had informed Mr. Colling and condo homeowners that the current practice stands, and "the MVF Board is fully aware" of the matter.

The condo homeowner governing regulation was written in 1973 when rental apartments were converted to homeowner condos. Rules, regulations and laws can change over time, with change in technology,

new developments or social mores. If the turnover occurred today, smart computer receivable programs would dictate that MVF collect its own fees. Importantly, only governing bodies can change formation documents and "laws," not the administrator.

The MVF Executive Committee, made up of select Board members, prepares the agenda the full Board will consider at its monthly meetings. The 2019 Board transferred that responsibility to the EVP, who chose topics and prepared the positions the Board would take. Certainly, that arrangement is more efficient, less time consuming and insulates the Board from having to deal

directly with homeowners. However, the result was that the 2019 Board became a rubber stamp for the EVP. The Board must do more than be "fully aware" of any issue that is its purview alone.

Hopefully, the 2020 MVF Board will take back its proscribed duties, and members will give their time and attention, directly, to homeowner concerns. The Board can rely on the staff to gather pertinent details of any issue, and will carry out the Board's determinations, efficiently.

## Montgomery County Board of Elections Recruiting students for "Future Vote" Program

The Montgomery County Board of Elections is seeking 1,500 school-age students in grades 6 to 12 to participate in its "Future Vote" Program. Future Vote students will serve as Election Day student aides during the 2020 Presidential Primary Election and during Primary Early Voting.

Students and their guardians must attend mandatory training to participate in the Future Vote Program and, if applicable, students will receive Student Service Learning (SSL) credits. This initiative combines civic participation and the opportunity to

observe democracy in action. The Future Vote Program is available to all Montgomery County students within public, private, independent, religious or home-schools. Students with bilingual and American Sign Language skills are encouraged to apply.

Since 2004, over 43,600 students have participated in the Future Vote Initiative, including thousands of high school students who have served as election poll workers after their 16<sup>th</sup> birthday.

Students ages 16 or older are eligible to register to vote and serve as election poll

workers. Each minor must demonstrate, to the satisfaction of the Maryland State Board of Elections, that they meet all qualifications for registration in the State.

Depending on the poll worker position selected, students may choose to earn up to 25 Student Service Learning (SSL) hours or up to \$210.

## 29<sup>th</sup> annual scholarship fund drive for Village high school seniors underway

Since 1991, the Montgomery Village Foundation (MVF), in partnership with Gaithersburg and Watkins Mill high schools, has awarded scholarships to deserving Village high school seniors totaling over \$52,000.

Scholarships are awarded to Watkins Mill and Gaithersburg high school students who have demonstrated outstanding scholastic achievement and participated in community or civic activities. recommendation to the MVF Board of Directors. Staff presented information about the fitness-based concept, including what MVF would be able to include within the permitted budget the functionality of proposed equipment on the market; and participation trends collected by nearby locations with outdoor fitness amenities. Based on that information, the committee recommended the MVF Board move forward with the process to repurpose the site to outdoor fitness use including a 150-meter asphalt exercise track, outdoor fitness equipment and moving the current playground to the front of the site.

The concept turns the seasonal amenity into a year-round amenity open to all residents. Currently, it proposes approximately 13 pieces of fitness equipment, allowing for 13 different simultaneous uses. A 150-meter asphalt track circles the equipment, allowing for running and walking opportunities. The playground, which is currently at the rear of the site (nearest to the townhouses), would be moved adjacent to the fitness equipment, inside the track area, allowing for supervision of children while using the equipment.

At the February 27 MVF Board of Directors meeting, the Board authorized proceeding

with an RFP for engineering services to repurpose the site. This will break out into three phases: 1) RFP to develop concept plan, site plan and permitting application; 2) RFP for demolition of current facility; and 3) RFP for contractors to install components outlined in design plan. Each phase will seek Recreation Committee input and MVF Board approval.

# Board appoints Scholarship Committee at February meeting

Each year, the Montgomery Village Foundation (MVF) sponsors a scholarship through the Gaithersburg and Watkins Mill high school PTAs to help further Village residents' education. The scholarship relies on donations from residents and a volunteer committee who selects the recipients each year. At the February 27 MVF Board of Directors meeting, Clare Conlon, David Cline and Sharon Levine were appointed to the committee. For more information on scholarship, including donations and the application process, see article on page 6.

## OTHER AGENDA ITEMS

A few key changes to the Procedures for Private Use of Facilities, recommended by the Recreation Committee, were approved to improve the offerings for residents. Changes include adding Stedwick Community Center to the list of available locations; a rate increase for higher occupancy locations; and a pilot program for the inclusion of light alcohol for functions at North Creek Community Center.

With the impending renovation of the North Creek Pool and Bathhouse, the addition

of Stedwick offers additional rental space for residents. Likewise, with a rate increase for the use of North Creek, offering Stedwick for smaller functions provides options for residents. The proposed rate increase would affect Lake Marion Gym and North Creek Community Center only; given their ability to accommodate larger groups, this is consistent with other local jurisdictions. Finally, as suggested in the Recreation Strategic Plan survey, under certain guidelines, residents will be able to have light alcohol (beer, wine, cider and champagne only) at functions approved in the North Creek Community Center.

These changes will be rolled out later this year, once staff is able to update the administrative portions of the procedures.

The Board also authorized bids to prepare some of its facilities for the spring and summer months. A bid of \$22,400 (with an additional 10% for unforeseen expenses) was awarded to All Pro Recreational Surfaces for the resurfacing, painting and striping of Apple Ridge Tennis Courts. All Pro Recreational Surfaces has done work for MVF in the past; they aim to complete the work by mid-April.

Additionally, High Sierra Pools, Inc. was selected to perform the de-winterization of MVF pools at a cost of \$18,000, plus time and materials work. High Sierra Pools, Inc. maintained their rate while other companies indicated a 3% increase. The Board also approved contracting with High Sierra Pools, Inc. for the 2021 and 2022 seasons if the perform favorably in 2020.

Finally, the Board approved moving forward with an RFP for engineering services for the repurpose of the Watkins Mill Pool to create an outdoor fitness space with an exercise track and playground. For more details on this change to the pool site, see the full article on page 1.

## PRESIDENT'S REPORT

Board President Glenn Gargan noted that the 2020 MVF Board election is underway. He reminded residents to return their signed ballots to the MVF Office, 10120 Apple Ridge Road, (either in person or by mail) no later than 5 p.m. on Friday, March 20. Ballots will be counted on Saturday, March 21 at 9 a.m. at the MVF Office.

Gargan also noted that recent questions regarding the

use of the new digital sign on East Village Avenue have started to come in. He asked that the Communications Committee discuss use cases and potential procedures at their next meeting.

## EVP REPORT

Executive Vice President (EVP) Dave Humpton reported on HB1628 - Sales and Use Tax, saying the idea behind the bill is to lower the tax rate and broaden the taxable entities. However, the tax impact to MVF and the Village's HOAs/COAs (and many other associations in the state) would be significant. By way of example, he noted based on 2019 figures, the bill would impose an additional \$30,000+ on landscaping expenses alone, just for MVF. All local associations would also be hit with increases based on their service contracts. The MVF Board noted opposition to this bill and asked Humpton to relay the hardship this would impose on all Village residents to the bill sponsors.

## TREASURER'S REPORT

Treasurer Bob Carey noted that MVF ended January on a positive, with both Revenue and Expenses favorable to the

budget. He reported that the unfortunate recent downfall of the market would surely see a dip in Investment Income. Carey said that overall Cash and Investments were at \$9.7 million (up from December and this time last year), which showed MVF is still maintaining a strong financial position.

## NEXT MEETING

The next MVF Board of Directors meeting is scheduled for 7 p.m. on Thursday, March 26, at North Creek Community Center, 20125 Arrowhead Road. The Annual Meeting is scheduled immediately following (approximately 7:45 p.m.). Residents are invited and encouraged to attend either or both meetings. The Annual Meeting will honor community volunteers and staff, as well as highlight 2019 accomplishments and financials. 

### 2020 VOTING INFORMATION FOR OWNERS OF PRIVATE DWELLING UNITS


1. For your ballot to be valid, assessments (including late payment fees) must be current through Dec. 31, 2019 (paid by Feb. 29, 2020).

6. Only one ballot may be submitted per private dwelling unit. If duplicate ballots arrive, the ballot with the earliest postmark will be considered valid unless it is personally withdrawn by the voter and another ballot is re-submitted.
7. **All ballots must be received at the MVF Office, 10120 Apple Ridge Road, by 5 p.m., Friday, March 20, 2020.**
8. Ballots will be counted Saturday, March 21, 2020, beginning at 9 a.m. at the MVF office, with results announced at the Special Election meeting immediately following.
9. The elected candidates will be introduced at the Annual Meeting of the Members of the Montgomery Village Foundation, Thursday, March 26, 2020 at North Creek Community Center, 20125 Arrowhead Road, at 8 p.m.
10. For Management Companies: Contact MVF to confirm you are the agent of record if owners designate the management company to vote on their behalf.

These procedures are required by the Election Committee in order to determine those eligible to vote and to ensure authenticity of voting. Any deviation from these procedures will result in disqualification of your ballot.



My name is Ricardo Camacho. I've been born and raised in the Village, and then after college, I've been a homeowner since 2013. I previously served on the Montgomery Village Foundation Board of Directors from 2014 to 2015.

**PETER WEBB**

My name is Peter Webb I live in Whetstone. We've been — my wife, Kate; my son, Will; and daughter, Marie — we've lived in Montgomery Village for 11 years.

2. Why are you interested in serving on the Montgomery Village Foundation Board of Directors?

**DANIEL ANDERSON**

I'm interested in serving on the Montgomery Village Foundation Board of Directors because I think it's going to be a great opportunity to utilize my

problem-solving skills that I've developed both professionally and by living in a bunch of different areas across the country, bring it into a community that seems to be coming back into its own, and I think I'm going to have a positive impact on that.

**RICARDO CAMACHO**

Community involvement is very important to me. I'm a third-generation resident of my family in the Village, and I really want to be involved in, you know, helping they can make sure the community continues to be a great place to live for all of its residents.

**PETER WEBB**

I think the biggest thing is I've served six years on the Board of Directors, and I'm looking to kind of continue the momentum that we have going in the Village. We just have so much going on with the Village Center finally getting redeveloped, the Bloom project getting off the ground and the Professional Center coming along. There's so much activity, so many things they've been working on for years, that I'm just really looking forward to pushing that forward for generations to come to enjoy Montgomery Village.

3. In what other ways have you been involved in Village affairs/service in the community?

**DANIEL ANDERSON**

I'm a pretty recent transplant to the area, but so far I've haven't had a lot of opportunities directly for this community. I've volunteered at some of the food banks in the area. I do volunteer through my work for

a couple of places in the area. I've enjoyed volunteering at the Montgomery County Fair; it's a been a great opportunity, but nothing directly to the Foundation.

**RICARDO CAMACHO**

Previously, I was a member of the Stedwick Homes Corporation Board of Directors and I've also been a member of the Montgomery Village Foundation Board of Directors, previously last in 2015.

**PETER WEBB**

When we initially moved to Eastgate, I served as the president of the HOA over there; which is one of the smaller parts of Montgomery Village, and from that I sort of learned about the overall community. My wife served on the Vision 2030 Committee, so that sort of got us in touch with what's going on overall, which drew my interest then just to run for the full Village Board of Directors. So, I initially ran six years ago for that and have served two terms serving that. In addition, I'm a member of the Whetstone PTA — and my son's in kindergarten there — and I'm also a business owner in the community, so I serve a couple thousand households as a financial advisor and a risk manager.

4. In your civic, professional or personal background, what experience do you feel qualifies you for a position on the Montgomery Village Foundation Board of Directors?

**DANIEL ANDERSON**

So, in my professional background, I spend a lot of time

interacting with people from this area, in a lot of diverse communities, getting to use some problem-solving skills to try to explain what could be impacting people and possible fixes for problems that you're experiencing. It definitely helped me come up with different ways of looking at problems and it's also given me a very acute interest in trying to find solutions that work within the constraints that we're given — whether that's budgetary or other availabilities of resources.

**RICARDO CAMACHO**

I work as an investment manager. You know every resident has to pay assessments every quarter, and so I'm keenly aware of, you know, the way the Montgomery Village Foundation manages the finances of the community. And they've done a great job of doing that in the past, and I'm committed to make sure that that continues in the future.

**PETER WEBB**

I think the one of my qualifications I think draws me most to serving is I started a young family in the Village, and we set down our roots here and took advantage of a lot of the opportunities that are unique to Montgomery Village. Whether it's the pools, whether it's the paths, walking to the Farmers' Market, my son plays t-ball through the Village, so being able to realize what the community offers kind of gives me a unique ability to come up with newer ideas and work within the structure to bring more to the community and help kind of develop newer, better or more modern programs.

5. What do you consider as priority items to be addressed by the Montgomery Village Foundation Board of Directors?

**DANIEL ANDERSON**

I think a good priority item for this time, in this area, is going to be trying to capitalize on the sense of revitalization to build a better sense of community. There is a good sense of community in this area, and I think there's an opportunity to help that be stronger.

**RICARDO CAMACHO**

I don't necessarily see a priority item. I think that the community's really run well, and I'm looking forward to re-joining the Board and working with my fellow members of the Board to, you know, make sure that the community is managed in a responsible and sustainable way going forward. Especially as a lot of the new development and changes happen in our community. I think this the Village is a great place to live, and I'm committed to make sure that it continues to be that way.

**PETER WEBB**

I think the two biggest items I have moving forward are continuing to focus on the redevelopment of the Village — bringing newer amenities like I'm sure we've noticed our newer pools or newer playgrounds the new construction going on is just going to bring such a more up-to-date, more modern flair to the Village that I think is just real exciting to kind of refresh everything about it'll be a big trickle-down effect of that. Also, I think it's real important that we continue to focus on our fiscal responsibility. The Village

is an incredibly strong position right now based on our investment structure and plans and savvy spending. Knowing what we are able to spend on or not puts the Village in a very excellent position that helps us keep assessments reasonable and also lets us upgrade with very unique and very state-of-the-art facilities that help separate us from other communities in the area.

6. *What proposals do you have to assist in implementing your priority concerns?*

**DANIEL ANDERSON**

I think that both an increased awareness of the community events that are already occurring, as well as I think a good low-cost item would be having somebody from the MVF Board or from the MVF employees getting on something like Next-Door and maybe once a week answering a couple of questions, maybe opening a thread where the residents can ask questions because there does seem to be a lack of communication sometimes. And I think that that could really help to grow the sense of community.

**RICARDO CAMACHO**

I don't have any specific proposals. I think the first thing as I rejoin the Board, I'd want to listen and see what the biggest challenges that are facing the Board are, and then work with the other members of the Board to solve those in a collaborative way.

**PETER WEBB**

I think the most important thing that we can focus on now is stability; maintaining our five-year visions; focusing on the strategic plans that we've worked out. And I think just being able to maintain that long view of our decisions now impact the community down the line for 10, 20 years, so just being responsible with what we do now. And also, I think it's important to focus on community engagement. In my six years on the board I've only recently started working with the Recreation Committee. Through them we were planning two local tot lots, and residents were able to come and pick the exact items they want. They say, "Hey we would like that" and it was different than what the committee had thought. So it was being able to see that actual engagement brought immediate results to what that community wanted. I think it's pretty exciting to try to educate residents on the whole that, hey, if you get involved, we've got the apparatus to listen. And so, I think just working with the community to try to get new or better ideas

and make sure we're tailoring our amenities to what the community wants.

7. *Montgomery Village is a very diverse community. Explain how you might engage residents of different backgrounds in community affairs.*

**DANIEL ANDERSON**

I think a great way to get community members more engaged from the diverse communities would be to meet them where they are and go to their events as well, and try to increase the feeling that we're all in this together. Because we all are in the same area and the concerns kind of cross those boundaries.

**RICARDO CAMACHO**

I think it's important — Montgomery Village is definitely a very diverse community with a lot of residents from a lot of different backgrounds. I think it's important for residents to be involved in the community. I think that the Montgomery Village Foundation does a great job of having activities on the weekends or during the summer that cater to residents of all kinds of different backgrounds and I really look forward to seeing continued involvement from all the residents in the Village so that everyone feels like they have a part to play in Village affairs.

**PETER WEBB**

I think diversity in the Village is one of our strongest assets. Like I was saying about the Rec Committee drawing in feedback — they've also been working at length at updating one of our tennis courts to become a futsal court. We heard in the community that, "Hey, this isn't an amenity that's offered really anywhere in the county," so through — and I know the Recreation Department and committee worked doing various community engagements and surveys, things of that nature — identified this as an item that the community wanted it and not necessarily somebody would have heard of before without having engaged the community. I also think items like we've worked toward publishing a lot of our documents in multiple languages — so people can read information in the languages they speak at home — which I think fosters a comfort with working with the Village and working with the Board if they think, "Oh, they care about me as a person because they're communicating in the way I want to speak." So, I think recognizing the diversity (as opposed to trying to eradicate it — is a poor thing to do) I think focuses on the strengths we have and how can we en-

gage that to form a stronger community for everybody who lives here.

8. *The Village is also home to many species of wildlife, and the MVF Board has adopted an Environmental Policy which includes the coexistence with wildlife in the community. Do you support this policy and how would you work to uphold it?*

**DANIEL ANDERSON**

I think that coexistence with the wildlife is an important facet of especially a green area like this. I think that the best ways to support that coexistence is reminding residents of what things that they can do that are going to minimize their impact on the wildlife we're sharing the area with. Also keeping in mind and looking for ideas on ways we can minimize the habitat fragmentation as we grow and develop in the area.

**RICARDO CAMACHO**

One of the best things about the Village is the awesome environment and surroundings that we have here in our community, and I think it's important — especially through the Committee on the Environment that the Montgomery Village Foundation has — to continue to make sure that we coexist in a sustainable way with all the different species of wildlife that we enjoy and we like having part of our community. And so, I'm committed to, you know, continuing to support the Committee on the Environment in their efforts to make sure that the nature that we live among is well taken care of.

**PETER WEBB**

I don't see how anybody could buy a home in Montgomery Village and not realize how beautiful it is. And the unique nature elements that you just don't get in any other community in this area. So, anything we can do to protect and help that thrive, of course I'm in support of. I think we have a great organization of trails and parks and paths, and I think we do a great job of maintaining them so they're safe and can flourish, but at the same time respecting the creatures that live there. And I think our natural resources are second-to-none and anything we could do to strengthen that is definitely something I've been in support of.

9. *What do you see as the future of Montgomery Village and what are your ideas for fostering that into reality?*

**DANIEL ANDERSON**

I think I see the future of the Village being a growing, revitalizing area — an area that's coming together more as a community as we bring in new

members to the MVF. And to see these activities growing in scope and seeing higher attendance because it's great to get out and meet my neighbors and those of us that live close even if we aren't quite neighbors.

**RICARDO CAMACHO**

So, I think Montgomery Village has a really bright future. There's a lot of new development and a lot of changes happening in our community that I think will be for the better. And I think we as Village residents are really looking forward to welcoming some of the new changes that happen and I think it'll continue to be, you know, the best community to live in here in the DC area.

**PETER WEBB**

I think the future is going to come pretty quick. I think we already see the groundbreaking in the Village Center we're going to see the Professional Center develop in the next 12 months. The future is going to be here quicker and I know it's been a long time coming, but we've got a lot of momentum going on. I think we're going to see a fresh housing stock. We will see our Central Park with the dog park and community gardens. There's going to be a lot of exciting stuff and a lot of new amenities that will allow us to program new things that weren't possible in years past. We've had the Farmers' Market taking off. Community concerts, community movies, recreational leagues — t-ball, softball, soccer — there's just all sorts of things that are just coming off the ground and are only going to continue to grow and flourish if we give it the right atmosphere to do so.

10. *Is there anything else you would like to share with residents regarding your candidacy for the MVF Board of Directors?*

**DANIEL ANDERSON**

I'm very happy to live in a green space that has as many trails and options for viewing wildlife — getting out and not being stifled in between walls. I think that this is a great community and it's going in great places. I'm very excited to be able to take what I've experienced in my past and the skills I've developed professionally, and see if I can help them or use them to help the community. I'm very excited for this opportunity.

**RICARDO CAMACHO**

So, I'm really looking forward to the opportunity to serve again on the Board of Directors and I'm looking forward to hearing from residents about what their what their concerns and what their priorities are for our community going forward as a whole. And I'm looking forward to be involved again.

**PETER WEBB**

I just look forward to trying to offer three more years of volunteering to keep this momentum going. I just can't stress enough how much great stuff we have going on. Our financial position is stronger than it's been as long as I've been in the Village. And at working with the Village Foundation to keep this momentum going, keep as many good things going and work with the county to try to improve our infrastructure as much as we can. I just think we're in a great spot and it's an exciting time to live in the Village and I'd like to see what the next few years bring us.

## Census 101: Everything you need to know about the 2020 Census

### What is the Census?

The Census is a nationwide count of every single person living in the United States. The U.S. Constitution requires a Census every 10 years. The first one took place in 1790.

### Why is the Census important?

- Our population determines how many seats Maryland has in the U.S. House of Representatives.
- The federal government distributes billions of dollars for government services and community programs based on census data. This includes things like school meals, pre-school programs, health-care access, road projects, affordable housing, and more.
- Census information helps to determine where we locate schools, immigrant resource facilities, hospitals, public safety facilities and other important services and resources.
- Businesses make important investment decisions based on census data.
- It is estimated that in the Maryland, every person not counted will cost the state \$18,250 in federal funding over a 10-year period.

### Who gets counted?

Every person in your household must be counted, including newborns. It doesn't matter their age, relationship to you, ethnicity or immigration status. Count everyone in your household. If you have relatives or children that split time in your home, they should be counted where they live and sleep most of the time.

### When does the counting start, and how do I respond?

Every household will receive a mailing from the Census Bureau in mid- to late

March 2020, inviting you to respond to the census online or by phone. You can use a smart phone, tablet or desktop computer. Note that residents who live in group homes, campus housing, shelters, etc. will be counted using a separate process. Only one person in the household has to respond, and should answer for all other people in the household.

### What happens if I don't respond?

If the Census Bureau has not heard from you by late April, after several reminders by mail, you will be mailed a paper questionnaire. If you don't return the paper questionnaire, a census worker—called an enumerator—will knock on your door and ask you the questions in person. The enumeration efforts take place in May, June and July.

### Is the Census available in other languages?

You can respond online or by phone in 13 different languages. While the Census questionnaire itself is available in 13 different languages, language guides to help respondents complete the Census are available in 59 languages.

### How long does it take to respond to the Census?

For most households it will take 10 minutes or less to respond.

### What questions are on the Census?

The Census asks certain questions in order to provide funding for programs that fit the needs of the community and to ensure that election districts are drawn fairly. You'll be asked for the name, age, date of birth, gender, relation, race, and ethnicity of every person in your home, and also whether your home is rented or owned. And that's it. Answer all questions as fully and honestly as possible.

### What questions will not be asked?

The Census will not ask for your immigration status, social security number, e-mail address, ID, financial or banking information or your political party. Please note that if you are asked to respond to the Census via e-mail, the request is fake and should be reported to the Census Bureau at [rumors@census.gov](mailto:rumors@census.gov) or 800-923-8282.

### Will my information be shared?

By law, your personal data cannot be shared with any other government agency, court or law enforcement agency. In fact, Census workers take a lifetime oath to not share your information. They risk prison and a fine if they do so. Your responses are aggregated with others, and statistical information for a community is derived from that. Note that your data remains private for 72 years, so, for example, the information from the 1950 Census won't be available to those doing family research until 2022.

### What does a Census worker look like?

If you do not respond in a timely manner, a Census worker—or enumerator—will visit your home. He or she will have a name badge and a bag with the Census logo on it. The badge will have their photo, a U.S. Department of Commerce watermark and an expiration date. You can ask for their identification at any time, but they cannot ask for yours. Please call 800-923-8282 if you would like to verify that the person is a Census worker.

## Deer fencing requirements in the Village

If you have deer jumping over your split rail fence, destroying that planting bed you worked so hard to build, or that garden that took lots of patience to grow, you may be interested in installing deer fencing.

Although hardware stores sell many different materials that can be used to build a deer fence, Montgomery Village has specific standards on what is allowed — check the website ([www.montgomeryvillage.com/residents/architectural-standards/village-wide-guidelines](http://www.montgomeryvillage.com/residents/architectural-standards/village-wide-guidelines)) for guidelines and submit an application before buying or installing any deer fencing. MVF only approves black or dark green metal posts with black or dark green mesh. This type of fencing is sturdy and requires little-to-no maintenance (wood fences, chain linked fences, galvanized metal or light green mesh are prohibited).

Deer fences are permitted on the rear and side of the property only — not in the front yard — with a maximum height of 8 feet. Keep in mind that deer are excellent jumpers and anything less than 8 feet can still allow deer to jump over the fence.

A Property Improvement Request (PIR) must be completed and submitted by the property owner before installation. Deer fencing applications will be approved on individual basis. This application can be picked up at the MVF Office, 10120 Apple Ridge Road, or can be found online at [www.montgomeryvillage.com/pir](http://www.montgomeryvillage.com/pir). The following items should be included with your application.

- A house location plat with the deer fencing location drawn on it
- Specified dimensions of materials to be used
- Color and description of materials — photos or links are always helpful for the review staff

Deer fencing applications are typically reviewed in-house by the Architectural Standards Department Director, review staff and the MVF Design Consultant every Thursday, and the average turnaround time is 10 business days from the date of submission to when a decision letter is emailed to the homeowner. The more complete the application, the faster the review turnaround.

Board membership is an important way to serve the community. The Middle Village board is responsible for adopting the annual association budget, which is the basis for the association fees. Additionally, the board is responsible for enforcing the community's covenants and rules and for ensuring that common areas are properly maintained.

There are three director positions open with expiring terms this year, each for a three-year term. If you are interested in serving on the board and accept fiduciary responsibility for the community, contact ComSource to obtain a Candidate Résumé Form. The completed form should be returned to the ComSource Office no later than Tuesday, March 31. Your résumé will be included (as submitted) with the official annual meeting notice to all homeowners. The official notice will confirm the time, date and location of the meeting, and will include a proxy statement with the name of any candidates. Members can also be nominated from the floor the night of the annual meeting.

### MOTORCYCLES

There have been numerous complaints regarding parking and storage of motorcycles on Middle Village property. Storing of all unlicensed motor vehicles, including motorcycles, is not allowed in accordance with the Middle Village Parking Policy: "The operation, parking, or storing of unlicensed motor vehicles (including "off-road" vehicles as defined in Article 27, Sec. 578 of the Maryland Code) is prohibited on the community-owned private streets or parking areas within Middle Village. The operation of motor vehicles by

unlicensed drivers is likewise prohibited within Middle Village. An unlicensed vehicle is one with no tags or one without current registration stickers. Unlicensed vehicles are subject to towing in accordance with state and county law, which permits towing within 72 hours after notice of violation is placed on the vehicle."

Covered motorcycles must be parked in the vehicle owner's reserved parking space, or they are subject to immediate towing: "Covered vehicles can only be parked in the vehicle owner's reserved parking space. Covered vehicles parked in open spaces are subject to immediate towing."

### TOWING

The current Middle Village Parking policy states:

"All vehicles parked overnight in the community are required to display a MVHC parking tag/permit or they are subject to immediate towing. For purposes of these Rules, overnight is defined as parking a vehicle in MV anytime between 11 p.m. and 5 a.m."

"Parking tag/permit must be clearly/properly displayed, on the driver's side, facing the front windshield, on vehicles parked in a reserved parking space, or parked in the community overnight. Tags/permits can be hung from the rearview mirror or taped to the driver's side dashboard or front windshield, front side facing toward the windshield."

"Failure to properly display the current year's parking tag/permit will lead to immediate towing - even if vehicle is parked in the appropriate reserved parking space. No warnings or notifications will be issued."

"No commercial vehicles or trailers of any type, campers, or recreational vehicles shall be permitted to remain overnight on either the property of a private dwelling unit or on the community-owned property within Middle Village. For purposes of these rules, overnight is defined as parking a vehicle between 11 p.m. and 5 a.m."

"Commercial vehicles include vehicles with any type

of writing or printing (letters, words, pictures, insignia, etc.) identifying a firm, organization, service, product, etc., of any kind, type or description. All vehicles carrying ladders, pipes, ladder racks, truck-loaded tools or truck-loaded tool boxes, etc., will be considered commercial. Vans used for delivering, storing or transporting goods or cargo are also considered to be commercial vehicles and are prohibited from remaining overnight in the community. Police vehicles are exempted."

"No commercial vehicles (including commercial pickup trucks) shall be permitted to remain overnight in the community. Pickup trucks must not have ladder racks, truck-loaded tools or truck-loaded toolboxes. Further, pickup trucks may not park overnight in the community with any cargo, items or material of any kind in the truck bed (landscaping debris, tools, boxes, trash, equipment, etc.) that exceeds the height of the truck bed sides or that extends beyond the tailgate. Pickup trucks with cargo that meet this description will be considered commercial vehicles and are not permitted to park in the community overnight. Violations are subject to immediate towing."

### DID YOU KNOW...

There's a pooper scooper law: Animal Defecation (Montgomery County Code, Sec. 5-203(a) (2))

An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the director. Feces may be picked up in a plastic bag. If this bag is placed inside another plastic bag, it may be put out for disposal in your normal household trash. Penalty for Violation - \$100.

### ASSESSMENTS

We live in a community that requires every homeowner to pay assessment fees. Assessments are used to pay contractors for landscaping, snow removal, trash collection, collection of illegally dumped trash, lighting, repairs on community property, etc. If you are a homeowner, you were provided with this information during closing.

Reminder: Assessments are due to be paid monthly. Your payment must be received by ComSource on or before the 15<sup>th</sup> of the month to avoid late charges. Your regular payments allow us to continue providing services to our community.

Homeowners who are delinquent with their assessment payments must pay their past due balance in full or make arrangements to pay them. The first step to making payment

# Spring is right around the corner!

An issue that continues to be a problem, and the board receives constant complaints from residents about, is trash. Residents are seen placing plastic bags of trash, recycling bins, paper leaf bags, furniture, appliances, etc. on community property daily! Not only is this unsightly and unsanitary, it's also against Montgomery County law and the Maryland Place by-laws.

All trash and recycling is to be stored on your property in a sealed rat/vermin-proof container at all times. Trash or recycling should never be placed on community property. As a result of all the plastic bags of trash left on community property, we now have a major rat problem. We are providing them with a buffet of food, in easy to chew through plastic bags.

The board has contracted Orkin to place rat bait stations throughout the neighborhood. These stations are child and pet proof. This service is not cheap, and the board will monitor it to see if it is helping with the rat problem.

As a reminder, all trash is to be placed in a rat/vermin-proof container for collection on Sunday and Wednesday nights, after dark, at the rear of your property. Trash is picked up on Monday and Thursday mornings. Recycling is to be placed in the front of your property on Wednesday night after dark, for collection on Thursday morning. At no time should trash or recycling ever be placed on community property.

# 2019 financial highlights

Our pre-audited financial statements for 2019 have just been completed, and our audit is underway. Our financial picture for the year ended December 31, 2019 as reported at our Annual Meeting February 20, 2020 is as follows.

2019 turned out to be a difficult year for us, with unexpected expenses leading to an operating deficit that we were not able to offset in other areas. Unlike private industry, we are not able to adjust our income to offset these unexpected expenses, and we ended 2019 with a pre-audit loss a tad over \$33,000. In 2018, we had a net income of \$34,000 for comparison purposes.

### INCOME

We are fortunate that the overall investment economy had another strong year, which enabled us to see unbudgeted interest income above last year. We also saw contributions from the roadway reimbursement program and bad debt recovery. These categories can't be budgeted, but the cash inflow from them is a net positive for our investment accounts and goes straight into the capital reserves.

### MAINTENANCE EXPENDITURES

2019 maintenance expenditures were budgeted at \$216,605, which was \$14,000 more than 2018. Yet we still ended up exceeding the maintenance budget by \$35,412. Much like all of us as individual homeowners, some maintenance expenditures have to occur regardless of whether you want them to or not. We faced the same situation in this category in 2019.

Attending to the landscape was the largest contributor to our deficit. Despite budgeting \$4,000 more than last year, our tree removal costs exceeded our budget by \$19,130. Our greenspace repair also exceeded budget by \$3,626, and storm damage earlier in 2019 was not budgeted or anticipated, leading to a \$4,125 deficit expenditure in this category as well. Tack on spending \$7,322 over budget in onsite maintenance. The slight savings in fence repair and fertilizer costs were not enough to avoid that \$35,412 maintenance deficit.

### TRASH AND SECURITY

These contracts are operating relatively smoothly. If you don't see security often, be aware that they devote more time to areas that seem to need it than to others. We did see a slight increase in the security contract, primarily related to the contractors' need to increase costs to meet new employee requirements enacted via the Montgomery County government. Overall, the two areas cost us 3% more than in 2018.

erty maintenance category, but at least there was an overall savings in this particular category as a whole. As our community ages, there are more violations of basic exterior home maintenance policy that need to be reported to homeowners and specific needs for repairs.

### CONTRIBUTION TO RESERVES AND CAPITAL EXPENDITURES

We added more than \$195,903 to our capital reserves during 2019, including \$141,500 from assessments, plus \$47,754 from interest on our investments and \$6,649 received from the county's roadway reimbursement program. At the end of 2019, we had over \$2,000,000 invested for replacement reserves. These reserves are consistent with our reserve study and keep us in a position to address planned capital improvements.

### THE YEAR AHEAD

As of February 6, we are still waiting to finalize the first month of 2020 financials, but we hope that some of the extra tree removals required in 2019 will be offset this year with some savings. True to our requirements, the budget doesn't exceed the allowable increases in the assessments. We will see the completion of the pathway lighting project in early 2020 as one of the capital expenditures that we are financially responsible for. The board also looks forward to having a positive financial position to end 2020.

### ADMINISTRATIVE (NON-MAINTENANCE) EXPENDITURES

In looking at this category of expenses, we actually saved over \$2,644, spending only \$153,584 compared to the \$156,229 in the budgeted items. We saved \$2,614 in electrical costs compared to the budget and another \$2,670 in legal costs versus the budget. These two could not completely offset the incursion of \$7,478 in costs on a \$5,000 budget for private prop-


Cuff spent 30 years in the classroom, and now uses her writing to continue educating audiences. Her previous


