As a commitment to the natural aspects of the Kettler vision, Montgomery Village has maintained its Tree City USA designation for the past 28 consecutive years, as well as participates in county programs and provides educational opportunities about nature and history. This year for Arbor Day, as part of the 50th Anniversary Celebration, we're doing just that. Join friends and neighbors to celebrate Arbor Day on Saturday, April 23 at the North Creek Nature Center, 20300 Aspenwood Lane. Enjoy free family fun, nature activities and service opportunities from 9 a.m. to 1:30 p.m.

MVF will re-open the doors to the Nature Center for this fun-filled day! Originally, the building was used as a bus stop for commuting to Washington, D.C., before it was moved to the current location. Since then, it has been used for nature camps and programs along North Creek Lake.

Begin the day at 9 a.m. with MVF staff and members of the Committee on the Environment to "Rake the Lake" at North Creek Lake. This important community service project involves removing litter and debris from the park, lake and lakeshore, in an effort to maintain the environment for the wildlife that live there and the aesthetic for visitors and passersby.

At 10 a.m., join the MVF Board of Directors for an Arbor Day Tree Planting at the lake. The planting is part of Montgomery Village's commitment to remaining a Tree City USA. MVF's landscaping contractor, The Brickman Group will donate the tree.

Following the tree planting, enjoy workshops on tree planting, creating a Monarch Butterfly waystation and Monarch Butterfly tagging. Families can take part in a nature walk around North Creek Lake, plant seeds to create a waystation, make butterfly-inspired crafts and take home seeds and seedlings to plant.

Parking will be available at the Nature Center lot on Shadow Oak Drive, as well as at North Creek Community Center; visitors will be directed through the tunnel under Montgomery Village Avenue for safe crossing to the activities. 

EVP'S MESSAGE

Montgomery Village Master Plan will bring change

Recently, a resident asked me what were the next steps with redevelopment of properties in the Village, following the county council's adoption of the Master Plan. Sometime in June, the county council will hold a public hearing to confirm the zoning described in the Master Plan for all properties in Montgomery Village. The Town Sector Zone will no longer be a single zone in the Village. In addition, between Park and Planning and the county council, as well as MVF community and committee meetings, there are many steps yet to be taken before any change is made.

Clearly Monument Realty is doing significant engineering work in preparation for redevelopment of the golf course, and Yovi Sever from Monument will give the MVF Board an update at the Thursday, April 28 MVF Board meeting. Also, plans are underway by the new owner of the Montgomery Village Center, Atlantic Realty Companies (ARC), to renovate and

redevelop that property. A community meeting was held on April 21 to review a new concept plan, and the MVF Board is expected to have further discussion about that plan at the Thursday, May 26 Board meeting.

The owners of the Professional Center and the property at the intersection of Lost Knife Road and Montgomery Village Avenue are also looking at options for redevelopment, and have met with me on several occasions. I will keep the community up to date as more information becomes available.

50TH ANNIVERSARY ARBOR DAY CELEBRATION AT NORTH CREEK LAKE PARK

One of the hallmarks of living in the Village is our beautiful parks and open spaces, much of which is well treed and home to many species of wildlife. We have been recognized by the Arbor Day Foundation as a Tree City for 28 consecutive years. Once again the MVF Board will join with community members to plant a tree near the North Creek Lake at 10 a.m. on Saturday, April 23, as part of this year's Arbor Day Celebration. My hope is that many Village residents will attend and participate in the activities planned for this year's celebration, another in the series of special 50th Anniversary activities planned for 2016. MONTGOMERY VILLAGE NEWS LETTERS TO THE EDITOR POLICY


- 1. The Montgomery Village News Letters to the Editor section is a community forum for Montgomery Village residents and/or property owners. In addition, at the Editor's discretion, the Montgomery Village News may print letters of appropriate interest to residents from others, including representatives of local schools, governments and businesses. Campaign letters are prohibited, except for Montgomery Village Foundation and Village homes corporation elections. The views expressed in the Letters to the Editor section are those of the authors of the letters and not necessarily those of the Montgomery Village Foundation (MVF) or its Board of Directors.
- 2. The *Montgomery Village News* will make every effort to publish all letters received during the weeks prior to publication.
- 3. Typed letters and e-mail must be received no later than 5 p.m. on the Monday prior to publication and distribution, while handwritten letters must be received no later than noon on the Friday, one week prior to publication. When a holiday occurs on a deadline Monday, Letters to the Editor must be received no later than noon on the subsequent Tuesday prior to the Friday publication and distribution.
- 4. Letters must bear the writer's name, address and telephone number for verification purposes. The sole use of pen names, initials or the complete omission of a signature will eliminate a letter from consideration from publication. A request from the author to withhold the name or mark the letter anonymous will eliminate the letter from consideration.

 5. All letters are subject to condensation or deferral to the next issue by the
- editor for space considerations, if absolutely necessary. Editor is to so indicate any condensations.
- 6. All letters may not exceed 300 words. Longer letters will be eliminated from consideration for publication in the Village News. As time permits, the writers may be notified and given the opportunity to shorten the letter for future publication. Letters exceeding 300 words which meet all other criteria of this policy may be published on the MVF website.
- 7. The *Village News* respects the privacy of individuals and residents; letters should not contain references to specific persons, except when endorsing candidates for MVF or Village homes corporation elections or referencing a previously published article with a byline.
- 8. Letters submitted by an author regarding the same topic must present new information or opinions; repetitive submissions and/or form letters submissions will only be printed once.
- 9. The Letters to the Editor section is not a forum for extensive debates; MVF encourages residents to use other avenues such as facebook and twitter for timely discussion.
- All e-mail is subject to this policy.
 The e-mail subject line must read "Letter to the Editor."
- All e-mail letters must include the writer's full name, address and telephone number for verification.
- As with letters delivered to the MVF office in person or by the U.S. Postal Service, the *Montgomery Village News* will make every effort to publish all letters received prior to the publication deadline.
- 11. MVF retains the right to respond to letters to the editor addressing specific issues involving it in the form of editor's notes or other methods at its discretion, and extends the same opportunities to homeowner or condominium association boards regarding letters specifically aimed at those boards.
- 12. Activity Card Update 2016



Summer is right around the corner, but before you head to the pool, make sure you have taken the necessary steps to ensure that you will receive your Activity Cards on time! You should have received an Information Letter and Rights Form (if needed) in early March. Even if there are no changes, we need a current Information Letter every year in order to process Activity Cards. If you haven't received the Information Letter/Rights Form, please notify the Montgomery Village Foundation (MVF) as soon as possible.

Residents of East Village and Maryland Place will be receiving new photo activity cards this year. Residents from communities that received photo activity cards in previous years, Eastgate, Northgate, Middle Village (Clubside), North Village, Patton Ridge, Poplar Spring, South Village (Dockside, Millrace, Nathan's Hill, Grover's Forge, Hamptons), Stedwick and Whetstone who do not yet have their photo activity card, will need to come to the MVF Office to get one this year.

Starting Monday, May 2, photos will be taken at the MVF Office, 10120 Apple Ridge Road, during regular business hours, Monday through Friday, 8:30 a.m. to 5 p.m. Beginning Thursday,

May 12, the office will remain open until 7 p.m. on Thursday evenings through July 7 and also be open on Saturdays from 9:30 a.m. to 12:30 p.m. beginning May 14 through July 9 (closed July 2). Please remember to bring proof of residence, such as a driver's license, so that we may take your photo.

Please note: If an assessment account is not at a zero balance as of April 30 in any year, beginning May 1, payment of any prior balance, as well as the full assessment amount through the end of the current fiscal year, must be received as a condition for issuance of an activity card or validation sticker.

Residents will need a current validation sticker on their photo activity card for entry to all MVF, Inc. pools. Validation stickers for the residents who have received their photo activity card in previous years will be mailed in early May, to those residents who have returned their Information Letter and Rights Forms (if needed), if their assessment account is current, and there are no architectural violations on the property.

At its most recent meeting, the Whetstone Board of Directors finalized language on an upcoming ballot regarding five proposed amendments to the Whetstone Homes Corporation Declaration of Covenants. Among these is a proposal to

prohibit the use of a Whetstone residence as a business that provides commercial adult day care.

I am writing this letter to make everyone aware of a dangerous situation that exists here in the Village. On November 21, 2015, while my wife was leash walking our dogs, one of our dogs was attacked and killed by a large Rottweiler that escaped from his backyard just feet from a walking path near Lake Marion that my wife was using. Our dog was walking quietly on a short leash, not growling or barking and was viciously attacked and died within seconds.

The owner of the attacking dog was found guilty in court and fined \$400.00. He was also ordered to have the dog

muzzled when outside. Not only was our dog killed, but my wife was traumatized as this horrific event happened right in front of her.

Unfortunately, this dangerous dog was not removed from the Village. Why was this dangerous dog not removed from the neighborhood? Because even though there had been complaints about this dog in the past, those complaints had been verbal with no written complaint being filed with Montgomery County Animal Control. Without a prior written complaint record, this dog could not be legally removed from its home, even though the animal control officer in charge

of this case felt the dog should be euthanized. That comment came after the officer spoke with the owner and observed the dog's aggressive behavior.

I am writing to inform Village residents of this danger and to encourage anyone with a complaint about a dog, especially if it is a safety concern, to file a written complaint with Montgomery County Animal Control. Don't let the dog's owner intimidate you into not acting—it may be a child's life you save and not just a dog's life.



North Creek is a tile-floored L-shaped room that may be divided into two smaller rooms with a maximum capacity of 125 people.

Anonymous tips can be used in conjunction with working with the 6th District Police to catch vandals. Help protect your investment in the community and make sure your assessment dollars are spent to further enhance the Village.

Townhouse fire out, damage limited

by the South Village Board of Directors

On Sunday, April 17, in the early evening, a townhouse fire damaged a Dockside residence on Sailfish Terrace. Fire crews responded in force, and there were thankfully no injuries. Preliminary reports suggest that the blaze may have started in a cooking appliance.

The lack of casualties and limited damage were good news, but it brings to mind some concerns about preparation in a townhouse community, where every household directly impacts another.

A few questions to help you prepare:

- Do you have an evacuation plan for your family in the event of an emergency? Does it allow for persons with limited mobility? Does it include children and/or pets? Where and how will you meet up if everyone isn't at home?
- Do you have a working fire alarm that you've tested recently? Most of our units have wired smoke detectors, but even wired units need to be replaced after several years. Check your detector and replace it if necessary. A replacement wired unit with battery backup can be yours for less than \$20 each. It's cheaper than replacing all your possessions, and certainly less risky to your life and the lives of those you hold dear.
- Do you have a working fire extinguisher that might buy precious minutes for you? Multi-purpose extinguishers that are

effective on a wide variety of anticipated home fires can be had for under \$40 in many hardware and supply stores.

More of a precaution: please don't leave heat-generating appliances (stoves, microwaves, dryers, and dishwashers to name a few) unattended. If you must be away from your house, please either wait to leave, or interrupt their cycles if required. This also applies to space heaters and candles—never leave these unattended or on when you are not in the room with them.

In the event you need to evacuate, do you have a prepacked bag with a change of clothing (perhaps including a sweater or old blanket), a three day allowance of necessary medications, and personal hygiene items for each household member? Having one handy can really improve your comfort and health in the event you have to leave your home for a short period.

Do you have a list of emergency contacts available on your smartphone or even on a piece of paper you carry in your purse, wallet or evacuation bag? Being able to call loved ones and those concerned for your safety without a functioning "speed dial" system can ease the worry in both directions.

Be fire safe—the life you save may just be your own.

North Village April board meeting

by the North Village Board of Directors

The April meeting of the North Village Board of Directors was held this past Thursday, April 21. The *Village News* went to press before the meeting so this article will only discuss items that were on the agenda. A full coverage of the meeting will be in the next issue.

Under new business there were four items on the agenda. The first item was the approval of the 2015 audit, which had been received as a draft several weeks ago and had been modified as a result of review and comments from the board.

The second item of new business was the review and affirmation of the corporation policies. North Village maintains 11 policies that govern everything from the use of greenspace and community property to snow removal. These policies are reviewed by the board every year and updates are made as needed. All of the policies are posted on your resident dashboard on the Montgomery Village website, www.montgomery village.com.

The next item of new business was the review and approval of a proposal for spring and fall fertilizer and weed control to all common lawn areas in North Village. Although we have an overriding contract with RJ Landscape Contractors Inc. for all of our lawn maintenance, this proposal was for fertilization and weed control, which are "extras" under the existing contract.

The final item on the new business agenda was the approval of a contract for the striping and reserve space painting in the Picton community. When the work gets approved and scheduled, we will alert residents so that they can remove their cars during the short time the paint is applied. Our community manager recommends that the work be done in late June or early July when there is less chance of rain and the weather is warmer so paint will dry faster.

There were several other maintenance matters that were to be brought up for discussion. Our community manager has submitted the Federal Emergency Management Agency (FEMA) application to the State of Maryland for public assistance for our snow storm expenses. Our community manager also had some new ideas for plantings around entrance signs that were presented to the board at the meeting. She also recommended that the board consider replacing the fence located at the entrance to the Picton community, since the fence is quickly deteriorating and is becoming an eyesore. To get started she recommended that a Request for Proposals (RFP) be sent to bidders also requesting feedback on design recommendations.

The outcome of all of these items, as well as any other business brought before the board, will be covered in our next *Village News* article.

MAINTENANCE UPDATES

Maintenance Inspection On March 28, the EVHC Maintenance Committee held their inspection of all common areas throughout East Village. The committee identified and approved additional plantings of annuals at the entrance signs of The Reach, Downs I (three total signs), The Estates and Gablefield; planting will be completed the first week of May. The committee also identified that the roads in The Reach were in need of being moved up on the reserve schedule for replacement and repair than originally scheduled; a replacement plan and an RFP are being prepared for the EVHC Board of Directors to approve at their Tuesday, May 17 board meeting.

Glenbrooke Stormwater Maintenance Pond – The two aeration fountains were reactivated, though one aeration fountain is not functioning; maintenance of the aeration fountain is scheduled to occur this week. Also, the regular maintenance schedule for algae and weed control will begin in early May, in addition to scheduled weekly trash removal within the pond and surrounding area on Fridays.

Storm Drain Cleaning in Essex Place – The drain in Essex Place has been cleared and is functioning again as designed.

Trash Rules and Regulations - EVHC reminds resi-

dents that both the county and EVHC require all trash to be placed in "vermin-proof" containers. All homeowners agreed to these rules and policies upon the purchase of their homes, and are also responsible for ensuring any renters or guests of their property are also aware and compliant. A "vermin-proof" container is a trash can with a tightly fitting lid. Loose trash bags left curb-side are not vermin-proof!

East Village trash collection days are Tuesday and Friday mornings, and recycling collection is only on Friday mornings. Trash and recycling containers should be placed out after 7 p.m. the night before collection. In addition to EVHC's frequent reminders, weekly community inspections are also underway to help identify and cite violators of the trash rules and regulations, to help improve compliance. Spring news

Spring cleanup is ongoing in Northgate, including branch pickup. Damage caused by winter storms is in the process of being repaired. Turf areas torn up by snow plows are being worked on by the land-scaping contractor.

The Montgomery County Fire Marshal is inspecting areas throughout the community looking for violations and determining if certain unmarked areas need to be designated as fire lanes. Should additional curbs be marked as such, it is due to this inspection. The Northgate board does not randomly determine fire lanes. Please remember that you can be towed immediately when parked in one.

At its April meeting, the board voted to replace up to 10 Pin Oaks (street trees) in Williams Range. The work was not done previously due to the repaving of the community.

It is almost mosquito time. While the most common mosquito in our area is the Asian Tiger, Maryland is in range of the Aedes mosquito, which spreads the Zika virus. We ask that you help prevent mosquito problems in the community by eliminating standing water sources such as: clogged rain gutters, tires, buckets, cans, bottles, flower pots, bird baths, children's toys, rain barrels and pet food and water dishes. The most effective method of controlling mosquitoes is reducing or eliminating the containers where the mosquitoes breed. Draining or removal of water holding containers will help control mosquitoes.

At its April 14 meeting, the Whetstone board finalized the ballot and explanatory materials for proposed amendments to Whetstone's governing documents. A town hall meeting for Whetstone residents is set for 7 p.m. on Monday, April 25 at the Whetstone Community Center, 19140 Brooke Grove Court. This will be an opportunity for homeowners to learn about the ballot initiatives and ask questions before the ballots are mailed out. Please plan to attend. PROJECT

On behalf of the Whetstone board, President Debby Vermillion presented a Certificate of Appreciation to Eagle Scout candidate Robert Maxwell for his renovation of the Canal Road and Digging Way pocket parks. The Maxwell family graciously donated four park benches for the project. The Brickman Group donated mulch, gravel and topsoil for the garden areas. Brickman's Mike Capobianco provided expert advice on plantings. The neighbors are delighted with their newly refurbished parks. Thank you, Robert!

PARKING

Residents have expressed concern about cars being parked at the Montgomery Village Avenue and Centerway Road entrances to Whetstone Drive, apparently by residents of nearby communities where there is insufficient parking. This parking is being done in a haphazard manner and has raised safety concerns—cars parked too close to intersections, blocking entrances, parked on green space and even double-parked. The board is considering the use of county-approved signs which are required before we can tow cars that are parked in an unsafe manner and which may deter so-called "walk off" parking.

MAINTENANCE ISSUES

The board decided to defer tree planting this spring because the bids came in significantly higher than what we normally pay. It is hoped

the bids will be more favorable in the fall.

The board authorized our community manager to go out for bids on tree pruning. Each year, Whetstone Homes Corporation prunes the street trees and those on common property in one fourth of the Whetstone community. This year, Lakeside is due to be pruned.

The maintenance committee will be surveying the entire Whetstone community for path repaving, concrete repair and tree removals in the next few weeks so that RFPs can be sent out for bids as required by our procurement policy. This is part of our annual maintenance work.

The board authorized the purchase of three post lamp tops which can use outdoor LED lights. Our current globes cannot. This begins the process of upgrading our post lamps. We are spending over \$10,000 each year just to repair/replace failing post lamps. The board will also be looking into various public and private sector programs to help pay for these energy-saving upgrades.

Spring cleaning has begun

Once again, spring is here and summer is coming up fast. Did you get all of your spring cleaning finished? You know, that stuff you have been meaning to take to the dump. If you're like me, you have to make multiple trips, your items are too big for the car or you just don't have the time. Well, here is a possible solution and a reminder to all Stedwick residents.

Stedwick trash services are provided by Potomac Disposal. Trash is collected every Tuesday and Friday for regular household items. But in case you did not know this, all homeowners are entitled to four free bulk pickups per year, for non-metallic items.

Just call Potomac Disposal at 301-294-9700 or visit www. potomacdisposal.com/bulk-pickup to schedule a bulk pickup. If you request a pickup online, you will receive a confirmation e-mail within two hours.

Just remember, all Potomac Disposal bulk pickups are scheduled for Fridays only. Make sure that you place the bulk pickup items next to your regularly scheduled trash Friday morning or no earlier than 7:30 p.m. the night before. As mentioned in the above paragraph, please confirm date of

next scheduled bulk pickup before sitting the items out.

Montgomery County ordinance requires that trash be put out in vermin-proof containers (covered plastic or metal cans) so that raccoons and crows cannot get into the trash and spread it around the neighborhood. For those of you who use plastic bags, please get covered trash cans.

Recycling services are provided by Montgomery County. Recyclables are collected every Tuesday in Stedwick neighborhoods except for Club Hill and Clusters I. Recycling in Club Hill is collected on Wednesday. Recycling in Clusters I is collected on Thursday.

Yard waste material can be recycled by placing it in the large brown paper bags available at most grocery and hardware stores, or in a container clearly marked "recycle," and set out on your regular collection day. Dumping those materials on the common area is inappropriate and requires our maintenance contractor to pick up and dispose of them—a waste of our assessment dollars.

PATTON RIDGE REPORT

The importance of following animal control laws

With spring now officially here, we can enjoy the outdoor activities and the nicer weather—and dogs are no exception. An important reminder from the Montgomery County Animal Control Laws that prohibits unleashed dogs outdoors that states:

"Any dog is at large if it is outside the owner's premises and not leashed, unless it is a service dog, is in a dog exercise area designated by the Maryland-National Capital Park and Planning Commission, or is participating in an approved activity. Any other animal (i.e., cat or livestock animal) is at large if it is outside the owner's premises and not leashed or immediately responsive to verbal or nonverbal direction. The common area of a homeowner's association, condominium or cooperative is not the owner's premises. Penalty for Violation: \$100 for first offense, \$500 for each subsequent violation.

The pet owner must prevent unwelcome or unsolicited threatening physical contact or close proximity to a person or a domestic animal that occurs outside the owner's property that may cause alarm in a reasonable person, such as biting, chas`ing, tracking, inhibiting movement or jumping. Penalty for Violation: \$500."

While we like our walks within the neighborhood, it's not uncommon to come into view of unsightly dog markings that get left behind. It's common courtesy to clean up after your dog and it shows respect for your neighbors and our community.

Making a difference only takes seconds and it's up to each dog owner to do their part in keeping the grounds and sidewalks poop-free. For those who may not know there is an Animal Defecation law on the books. Montgomery County Code, Sec. 5-203(a)(2) better known as the "pooper scooper" law states, "An owner must not allow an animal to damage or defecate on property outside of the owner's property. An animal may defecate on public property or the common area of property in which the owner shares an interest if the owner immediately removes and disposes of the feces by a sanitary method approved by the Director. Feces may be picked up in a plastic bag. If this bag is placed inside another plastic bag, it may be put out for disposal in your normal household trash. Penalty for Violation - \$100"



MV Kids learn about Voting

One of the most important events in American government and politics is the election of the President. This event is held every four years and is compared to a race. We say that someone is "running for office" and that the "Presidential race" is on. Maybe you've heard your parents talk about particular candidates who are running for office or important issues that affect the way you live.

What is the Electoral College?

The Electoral College was established by the U.S. Congress in 1789 because the founding fathers were concerned that presidents would always come from states with high populations. They also wondered if voters would have the knowledge to make a wise choice.

The Electoral College is not really a "college" but a process using "electors" chosen from each state.

How does the Electoral College Work?

The people in each state vote for a candidate. Those votes instruct an "elector" from your state to cast a vote for the same candidate. The candidate who gets the most popular votes in each state gets all of the electoral votes for that state. The electoral votes for all 50 states are added and the candidate with the most electoral votes is elected President of the United States.

How Many Electoral Votes For Each State?

The number of electors from each state is based on the state's representation in Congress. For example, the state with the highest population, California, has 55 electors. The states with the lowest population—Alaska, Delaware, Montana, North Dakota, South Dakota, Vermont, and Wyoming—have three electors each.

How Many Electoral Votes Are Needed to Win?

There are a total of 538 electoral votes. To be elected, a candidate must receive a majority of the electoral votes—at least 270 votes.

How do we get 538 electoral votes? 100 senators + 435 representatives in the House + 3 electors for Washington, D.C. = 538 electoral votes.





Darnestown and Montgomery Village. In those sanctuaries of nature, a flightless duck, a domineering black squirrel, an aged squirrel and mischievous baby groundhogs all had their stories to tell.

Fain, who lived in Montgomery County, including Montgomery Village, from 1965 until 2010, has published "Mystical Animals of Ancient Oak." A long time civically active environmental and animal protection advocate, Fain writes about true stories that

reflect the healing that comes with time spent in nature. The timely subject of remembering to honor life in this era of chaos and technology is echoed throughout the book.

The book focuses on the animals Fain encountered during time spent in Ancient Oak, Darnestown, as well as the South Valley Park in

the Village. As the region's forest habitat and greenspace was lost to development, the importance of finding nature and parks became increasingly important to people and animals.

Fain says in the book, "Follow the road to Ancient Oak and South Valley Park, and learn to find healing in the animals and nature around you. Through surprising and unique ways, animals find their way into our lives and show us what we have long forgotten."

Fain served on the West Montgomery County Citizen's Association Board of Directors from 2009 to 2011. She was also an active member of the Wildlife Rescue Committee and MVF Committee on the Environment from 1992 to 1995. Additionally, she worked and volunteered for non-profit animal protection organizations, including Maryland State Government – Maryland Environmental Trust.

- Both commercial packets and saved seeds should have

about 20 seeds per packet (understandably, this can vary if seed size is extremely large or small)

 Identify each packet of seeds with a white label with the following information:

Category (please keep to these seven categories): Edible, Herb, Annual, Perennial, Native, Exotic or Woody (Tree Or Shrub)

Plant name: common and Latin (if known)

Year collected or purchased (no seeds older than 2013, please):

Optional info: other useful information on growing conditions, seed collection or purchase location, expected size of plant and possible problems

geographical areas. Also, it has "Rotaract" clubs for men and women of college age and 'Interact" clubs in high schools.


