# Get ready to cool off in Village pools

Even though we've had some unseasonably cool temperatures lately, it's that time of year again-pool season is upon us! And what better way to beat cooler air temperatures than getting a swim in a heated pool? Stedwick Pool, 10401 Stedwick Road, will open on Saturday, May 21, before the other Village pools open. Stedwick will be open weekdays from 3:30 to 7:30 p.m. (closed Thursday) and on the weekend from 2 to 7:30 p.m.

Saturday, May 28 at noon, is one of the most anticipated events in Montgomery Village all year – the opening of MVF-owned pools and what many see as the beginning of summer in the Village.

Apple Ridge, Lake Marion, North Creek, Stedwick and Whetstone pools will be open Memorial Day weekend. Watkins Mill and Hurley Park pools will open on Tuesday, June 21. Each of the seven Montgomery Village Foundation pools will be open six days a week and closed one day, on a rotating basis, for maintenance. Each has weekend and weekday hours; the 2016 Pool Schedule is available online at www.montgomeryvillage.com, and is posted at each of the pools.

Lake Marion, Stedwick and Whetstone pools will remain open through Labor Day, Monday, Sept. 5; the other four pools will close earlier in August—check your pool schedule for details. Stedwick Pool will remain open through Sun-



# Retreating...not at all! Much work to be done....

The Annual MVF Board Retreat was held on Friday, May 13 and Saturday, May 14. The retreat is an opportunity for the Board to have discussions about short and long term goals, and review long term financial assumptions that are included in the annual budget and 5-Year Financial Plan. The Board also discusses areas for improvement or enhancements to services or programs. Prior to the retreat, Board members provided specific topics that they would like included on the agenda. The theme of this year's retreat was the "Future of..." and the Board discussed topics including the future of MVF parks; the future of MVF pools; the future of community development projects; the future of user fee programs, including camps and classes; and the future of Board governance, among others. Discussions at the retreat assist staff in preparing strategic goals included in the upcoming budget and 5-Year Financial Plan.

# THE FUTURE OF... MVF YOUTH SPORTS/ CAMPS

I read, with interest, a recent Washington Post article that chronicled a national conference focusing on declining participation in youth sports across the country. This is an issue that our sports program partner, Montgomery Village Sports Association (MVSA) has been dealing with for some time with certain sports such as baseball and softball, and to some extent, lacrosse. The partnership consists of MVSA's providing coaches and programs, while MVF provides fields and facilities.

MVSA does have an outstanding football and volleyball program that many of our youth benefit from, and over the years, the partnership with MVF has remained strong. MVSA leaders and MVF will continue to examine what works and what isn't working and adjust programs accordingly so as to provide the best alternatives for our young people and their families.

I think that some of the points in the Washington Post article describing why youth sports programs are declining might be applicable to why MVF camp enrollment has declined as well. The MVF Board and staff are reassessing MVF's camp program for 2017 and beyond because of the decline in camp enrollment over the last couple of years.

What is causing this trend? Are our camps too costly for our residents? Is the too slowly improving economy making it more difficult for parents to send kids to camp? Are more of our young people attending county programs at schools, which are free or very affordable, instead of attending camps? Are more kids being supervised at home and just not attending camps? Are we doing enough marketing of our camps? Are there just more camp options out there for MVF to compete with? Can our camps compete with fullday daycare options? I think it is probably a combination of all these factors, but I am convinced that affordability is

If you look at the percentage of students in Montgomery Village schools who are eligible for the Free-and Reduced-Priced Meals Program (FARM), it leads me to believe that our changing demographics require us to rethink our camp programs and their pricing. MVF is in stronger financial shape than it has been for a long time, and the Board wants to make sure that we are offering camps and classes that are fun, enriching and affordable, while keeping assessments as low as possible.

# **MONTGOMERY VILLAGE NEWS LETTERS TO THE EDITOR POLICY**

- 1. The Montgomery Village News Letters to the Editor section is a community forum for Montgomery Village residents and/or property owners. In addition, at the Editor's discretion, the Montgomery Village News may print letters of appropriate interest to residents from others, including representatives of local schools, governments and businesses. Campaign letters are prohibited, except for Montgomery Village Foundation and Village homes corporation elections. The views expressed in the Letters to the Editor section are those of the authors of the letters and not necessarily those of the Montgomery Village Foundation (MVF) or its Board of Directors.
- 2. The *Montgomery Village News* will make every effort to publish all letters received during the weeks prior to publication.
- 3. Typed letters and e-mail must be received no later than 5 p.m. on the Monday prior to publication and distribution, while handwritten letters must be received no later than noon on the Friday, one week prior to publication. When a holiday occurs on a deadline Monday, Letters to the Editor must be received no later than noon on the subsequent Tuesday prior to the Friday publication and distribution.
- 4. Letters must bear the writer's name, address and telephone number for verification purposes. The sole use of pen names, initials or the complete omission of a signature will eliminate a letter from consideration from publication. A request from the author to withhold the name or mark the letter anonymous will eliminate the letter from consideration.

  5. All letters are subject to condensa-

tion or deferral to the next issue by the


- editor for space considerations, if absolutely necessary. Editor is to so indicate any condensations.
- 6. All letters may not exceed 300 words. Longer letters will be eliminated from consideration for publication in the Village News. As time permits, the writers may be notified and given the opportunity to shorten the letter for future publication. Letters exceeding 300 words which meet all other criteria of this policy may be published on the MVF website.
- 7. The *Village News* respects the privacy of individuals and residents; letters should not contain references to specific persons, except when endorsing candidates for MVF or Village homes corporation elections or referencing a previously published article with a byline.
- 8. Letters submitted by an author regarding the same topic must present new information or opinions; repetitive submissions and/or form letters submissions will only be printed once.
  9. The Letters to the Editor section
- 9. The Letters to the Editor section is not a forum for extensive debates; MVF encourages residents to use other avenues such as facebook and twitter for timely discussion.
- All e-mail is subject to this policy.
   The e-mail subject line must read "Letter to the Editor."
- All e-mail letters must include the writer's full name, address and telephone number for verification.
- As with letters delivered to the MVF office in person or by the U.S. Postal Service, the *Montgomery Village News* will make every effort to publish all letters received prior to the publication deadline.

# **Activity Card Update 2016**



Summer is right around the corner, but before you head to the pool, make sure you have taken the necessary steps to ensure that you will receive your Activity Cards on time! You should have received an Information Letter and Rights Form (if needed) in early March. Even if there are no changes, we need a current Information Letter every year in order to process Activity Cards. If you haven't received the Information Letter/Rights Form, please notify the Montgomery Village Foundation (MVF) as soon as possible.

Residents of East Village and Maryland Place will be receiving new photo activity cards this year. Residents from communities that received photo activity cards in previous years, Eastgate, Northgate, Middle Village (Clubside), North Village, Patton Ridge, Poplar Spring, South Village (Dockside, Millrace, Nathan's Hill, Grover's Forge, Hamptons), Stedwick and Whetstone who do not yet have their photo activity card, will need to come to the MVF Office to get one this year.

In reference to "ARC shares plans to revitalize Village Center," (MV News, May 6, 2016), I have several concerns. Are ARC's goals are juxtapositioned with the community's needs?

- Can ARC improve the mall's appearance and good stores and concurrently satisfy an increasingly diverse community? Global provides a great variety of seafood and ethnic foods. Many low-income Global customers in the immediate area have little or no transportation other than walking.
- What certainty is there that a national chain grocery would want to anchor the mall, given the past experience of Giant Foods?

- If another grocery replaces Global in the mall, how long would the immediate area be without a grocery, awaiting the transition?
- Is Grape and Grain, which has long served this area with friendly service and good products, being given a relocation option?
- What would be the impact of increased housing (the apartments) on schools and area traffic, which is already heavy?
- How will the new owner avoid the situation that's developed in the former YMCA site, adjacent to the mall? We heard optimistic projects about offerings that would benefit the community? Since then, (1) a bank relocated,

then closed after a couple years; (2) a dry cleaner (2nd in the mall) opened and closed; (3) a Thai restaurant opened and closed after a few months; and (4) a new, high-quality restaurant announced that it would open, but changed its mind. Upshot: A few small stores, which include one good Chinese carryout and several empty storefronts.

I believe the entire community is in favor of some change and a revitalized village mall, but I am skeptical about change that amounts to gentrification much of the gentry has left the area. We now have a vibrant and diverse community.

# Large trucks and their calling cards

It is not just a problem on your street. It is a problem throughout Whetstone, and indeed, throughout Montgomery Village. Large vehicles such as trash and recycling trucks, school buses and delivery vans and trucks have difficulty turning corners on our streets. When they have trouble, their tires often go

over the curb and damage the turf. There is also curb damage from these heavy trucks.

The damage can be especially severe on days when it is raining or the turf is wet. The tires sink into the wet grass and leave large ruts. I have seen ruts as deep as 12 inches, two tires wide, and about 30 feet long on the grassy island on the cul-de-sac in front of

my house. The mud from the tires can extend all the way up

So, what to do about it? I have tried talking to some of the drivers; unfortunately, the drivers change, and it is hard to determine who was responsible for the damage or if the truck was blocked by parked cars and had little recourse. On recycling days there are pickups by two different trucks. There are trash pickups on two other days each week. There can be daily school bus traffic on some of our streets. And there is the more-thanoccasional delivery van/truck.

Most of the damage is done to Whetstone community property, e.g., the pocket park areas in the middle of some of our streets, or the grassy lawn areas at the turns onto our streets (which are usually contiguous with a homeowner's lawn). The Whetstone board has tried various things to try to alleviate the problem and keep the common areas looking attractive, e.g., depositing

large rocks at problem corners, or replacing damaged sod with a layer of river rock. We have also replaced or repaired broken curbs. These fixes are not inexpensive, nor are they always the most attractive, though more so than a deep, ugly furrow or a persistent, muddy hole. Our first choice is for the trucks to stay off the grass!

I believe there is something we can all do to help alleviate the problem. In principle, the solution is simple, although it takes a little sacrifice and forethought: just don't park on that part of the street where your car would prevent the trucks from making a clean turn.

For example, on my street, the four residents living on the cul-de-sac have agreed to not park on the street in front of their houses until the trash and recycling trucks have completed their rounds. Instead, we park either in our driveways or on the straight part of our street where the trucks have no problem in their passage.

Since we have been making this effort—almost 2 months now—there have been no problems. Since we have single driveways and two cars (or more at times), this has sometimes meant making the extra effort to move one car to let the other car out and then moving the first car back into the driveway or up the street and out of the way. We also ask visitors to park a few doors up, along the straightaway, when we are expecting the trucks.

Personally, I prefer this solution to any other land-scaping option available to the Whetstone board — neighbors working together to keep our community looking good. Why not talk to your neighbor and see if you can make it work too? We're all in this together.

# VOTE WHETSTONE UPDATE

Due largely to feedback received at the well-attended Whetstone Town Hall Meeting on April 27, the ballot item relating to the possible replacement of the Whetstone dock/ gazebo has been changed. Instead of offering a "dock only" or "dock plus gazebo" replacement option as discussed at the meeting, the ballot will ask you to choose between "dock" or "no dock," i.e., do you vote to build something similar to the previous dock, or do you vote to not replace it at all.

The VOTE WHETSTONE ballots are expected to be mailed to residents by the end of May. Besides the dock replacement question, there are five other important questions that require your feedback in the form of a vote. Our goal is to get 100% participation so the Whetstone board can properly assess the intent of the community. A second town hall meeting is planned for mid-June so all can have the opportunity to learn more about the issues and participate in discussing the pros and cons.

### **2016 PARKING TAGS**

### **TRASH**

Do not place any trash, including bulk trash out prior to the pickup days of Tuesday and Friday. If you see a resident dumping bulk or loose trash and you know their address, you can report them to ComSource anonymously.

It is the responsibility of each resident to place their trash can in the appropriate location for pickup, and to collect their trash cans/recycling containers and place them back on their property on the day that trash/recycling is collected.

Unmarked trash cans and recycling containers are often left in common areas all week. This attracts rodents, and has a negative impact on the appearance of our community and our property values. Any trash cans or recycling containers that are not marked with an address will be collected and disposed of.

# Tree plantings

As we mentioned in earlier articles, Pepco has given us a voucher to replace 14 trees that they removed around power lines for reasons of improving system reliability. Your board of directors will be selecting trees from the following list of flowering trees: American Holly, Redbud, Flowering Cherry, Dogwood, Purple Leaf Plum, Serviceberry, Crepe Myrtle, Forsythia, Hawthorne, Viburnum, Crabapple, Eastern Red Cedar and Emerald Arborvitae. The trees will be planted in the fall, and our maintenance committee will be selecting appropriate locations throughout the community. These beautiful trees will certainly enhance the appearance of North Village.

# **MAINTENANCE**

In her monthly report, the maintenance committee chair reported that the flower bed at the Picton entrance sign has been planted. Also, orange tape has been placed around the new flower bed in Perry Place to keep the children from

stepping on the flowers. More recently, plantings around other entry signs have been completed.

She also noted that the "No Loitering" sign in Picton has been down for a number of months. A temporary fix has been made with plastic ties, but that may not last long, and a more permanent fix will be needed. The lights still have not been fixed in the inner court at Chadburn Place, and the tall carriage light #1 is still not working after 15 months. The electrical contractor will be notified. Finally, our contractor has been asked to replace missing or damaged rails in our split rail fences around North Village.

Parents, please remind your children to be good to our environment and teach them to pick up all of their empty water and juice bottles, etc. when they are done playing. They are never too young to learn to recycle and help keep up the appearance of our community. And as you are walking your dog or just out walking for exercise, please pick up and dispose of any trash that you

see. Remember that you are a co-owner of the paths and common areas and we all have to play our part in keeping our neighborhood clean.

As spring is well underway and summer is just around the corner, we remind residents that they are responsible for the appearance and maintenance of their property, including any attached or detached additions and improvements such as garages, patios, decks, walks, driveways, fences and play equipment. Residents must also maintain yards in good order and repair, free of weeds, debris, garbage, pet droppings and other conditions deemed to be in non-compliance of the Maintenance Policy. Owners are responsible for normal upkeep such as seeding, fertilizing, watering, mowing and pruning and cutting of shrubs/ trees and other flora to prevent overgrowth. Failure to perform the following shall be considered non-compliance:

- Grass must be mowed at regular intervals so that the height does not exceed a
- maximum of eight (8) inches • Gardens and flower beds

are encouraged but must be maintained to prevent overgrowth, dead or diseased plants or the proliferation of

- Composting facilities must be maintained and present an orderly appearance
- Pet waste on an owner's property shall be disposed of in a sanitary and timely manner
- · Conditions that present an unsightly appearance within the community must be ad-

# **New trees coming to Stedwick**

The planting of native trees in our community by Montgomery County to reduce storm water runoff is now scheduled to happen this fall. The maintenance committee is also exploring the possibility of planting additional "street" trees. They would be provided by Montgomery County's Street Tree Program, and would be planted close to, and along, Stedwick Road.

Three piles of tree trunks and other pieces of large trees have been placed on both sides of Stedwick Road near the Stedwick Community Center. They are the remains of trees that were cut down from the Pepco power line easement to reduce the chances of them falling onto the power lines that run along the northwest edge of the Pepco right-of-way. Many of those trees have been removed from Stedwick Homes Corporation community property, along the east edge of the Clusters II community and in the wooded area between Frenchton Place and Montgomery Village Middle School. Pepco's tree removal contractor has cut the trees down, but apparently will not grind the stumps, leaving the Stedwick Homes Corporation to deal with them at our expense, if we choose to grind them.

About a year ago, Pepco's tree removal contractor had identified trees at the entry to Club Hill and across Watkins Mill Road for removal, and had indicated that they would be removed last fall. We anticipate that those trees will be removed as part of these overall tree removal activities.

Overall, the Stedwick Community is losing our tree cover faster than it can be replaced.

Our landscape maintenance contractor has been working with Montgomery County to establish RainGardens and RainScapes in Stedwick, and has received tentative approval for implementing two of them in the Burlingame Steam Valley area and one in Clusters I.

# Girl Scout Gold Award project at Stedwick Elementary School

Fourth graders at Stedwick Elementary School have spent the past winter learning how to soar and float. They finished off their STEM experience making their own lava lamps.

Students from Watkins Mill High School have joined them once a week to teach science in a fun and interesting manner. As a part of Girl Scout Jennifer Milhiser's Gold Award project, she and her friends worked with the fourth grade classes at Stedwick on unique STEM projects.

While studying aerodynamics, the children discovered how to tweak their paper airplanes to make them soar higher and farther. For buoyancy, they formed groups to build a boat out of tinfoil that could successfully hold a load of pennies.

The final project on density involved the students making their own lava lamps, and learning about density across different kinds of liquids.

The STEM club at Stedwick began 4 years ago as an 8-week after school program. When the school announced elimination of its after school activities due to the MCPS change in school times, Stedwick Principal Dr. Pastor instituted a 30-minute end of the day enrichment period for the kids to learn outside of the curriculum. Jennifer took advantage of that enrichment period to propose the expanded STEM club for the entire fourth grade class to enjoy. Dr. Pastor quickly approved the program.

Starting in February, a small group of high school students have gone to the school 12 times to teach the kids about various science experiments and activities. Many of the students Jennifer organized were Stedwick alumni, creating a link between the classes.

This kind of display of fullsize American flags, on Memorial Day, was put up by the Rotary Club of Easton, Maryland in 2013. The Rotary Club of Montgomery Village followed their example in 2014 recent immigrants to the USA.

Rotary was founded in Chicago, Illinois in 1905. It is now an organization of some 34,000 clubs in nearly every country in the world. It is non-political and non-religious, and membership is open to everyone. It has a major philanthropic foundation that supports local clubs in funding activities to promote peace, fight disease, provide clean water, save mothers and children, support education and grow local economies.

Also, Rotary Clubs throughout the Washington, D.C. area engage in numerous activities that benefit their local communities. For example, they donate dictionaries to third grade students and provide funding to Galluadet University, which is for students with no or very limited hearing. Most Rotary Clubs support groups in high schools, called "Interact Clubs," and some have founded groups in universities called "Rotoract Clubs."

The organization as a whole is one of the "big three," with the U.S. Government and the United Nations, that are working together to eradicate polio worldwide, and has nearly completed that task. It has international studies programs such as Ambassadorial Scholarships and Peace Fellowships in "peace universities" that have been set up in the USA and five other countries.

You can create a garden that attracts beautiful wildlife and helps restore habitat. By providing food, water, cover and a place for wildlife to raise their young, you can make a healthy and sustainable wildlife habitat.

# **Providing Food and Water Naturally**

Local flowering plants, shrubs and trees provide leaves, nectar, pollen, berries, seeds and nuts that many species of wildlife eat to survive and thrive.

In winter, when natural food sources are not as available, it is important to also provide feeders for birds, butterflies and squirrels.



Your habitat should include some of the following: Seeds from a plant Berries • Nectar • Leaves/Twigs • Nuts • Fruits • Sap • Pollen



Wildlife need clean water for drinking, bathing and reproduction. Water may come from natural sources like ponds, lakes, rivers or creeks; or human-made features such as bird baths, puddling areas for butterflies, installed ponds or fountains.

# **Build a Brush Shelter**

Start by stacking and criss-crossing logs, then branches in a way that creates runways and spaces large and sturdy enough for small animals. Continue adding branches large to small in a criss-crossed weave.

Wildlife attracted to this type of habitat are dragonflies, lizards, butterflies, rabbits, turtles, sparrows, toads, mice and groundbeetles and quail. You might even see woodpeckers pick insects out of the wood.



# Your Own Monarch Waystation In case you missed the 50th Anniversary Buttoufly M

In case you missed the 50<sup>th</sup> Anniversary Arbor Day Celebration at North Creek Lake, here's what we learned about making a Monarch waystation or habitat.

Waystations are places that provide Monarch butterflies with milkweeds throughout their spring and summer breeding time, and nectar from flowers for these fall migratory monarch butterflies to make their long journey to Mexico. The need for host plants for larvae and energy sources for adults are also necessary.

A good variety of the following plants and flowers are recommended to create a successful monarch habitat:
