MVF 2023 Draft Budget overview

As Montgomery Village Foundation (MVF) staff works to prepare the 2023 Draft Budget for review, initial projections show another conservative budget focused on keeping assessment rates as low as possible and continuing to provide a high volume of services to Village residents. The below preliminary summary reflects a proposed, non-approved outline for FY23.

Currently, staff estimates no assessment increase for the MVF Fund and a \$2.50 increase for the DU Fund. While continued review of the 2022 budget may change these estimates, the current proposed assessments are: MVF Fee - \$21.52 per unit, per month; DU Fee - \$42.27 per unit, per month.

Overall Expenses are projected to total \$3.2 million from the MVF Fund and \$3.3 million from the DU Fund.

Despite inflationary pressures driving up Personnel, Operating and Reserve costs, Undesignated Reserve Balances would be used to offset increases in the MVF and DU fees. For FY23, \$148,461 and \$36,037 are proposed to be spent from MVF and DU Undesignated Reserves, respectively.

MVF estimates a total Contribution to Reserves of \$1,500,706 and total Reserve Expenses of \$1,852,224 (\$750,616 from MVF and \$1,101,608 from DU). The Reserve Study is currently be-

6th District Police talk public safety in the Village

On Monday, July 25, Montgomery County 6th District Police Commander Eric Stancliff and several of his staff provided a public safety update for members of the Montgomery Village community. Stancliff was joined by Lieutenant Suh, Lieutenant Helton, Detective Urriola and Community Services Officer Kim Jones, noting that many of his officers, himself included, have been long-time county residents, so they understand the dynamic of working in the 6th District.

Stancliff mentioned that at the moment, law enforcement nationwide is experiencing a hiring and retention issue. Specifically in Montgomery County, he noted that there a many senior officers eligible for retirement, and due to recent scrutiny on law enforcement, many younger officers are choosing to make a career change. Couple this trend with low police academy class numbers, and it's not hard to see that hiring has become hard across the country.

Due to the lack of officers, Stancliff had to make the difficult decision to pull the dedicated Montgomery Village Team, and place them back on regular duty within the 6th District. He said the six positions for this team will be retained, however, he feels it will be a few years until there are enough officers back in action to reestablish the MV Team. He also mentioned that due to lack of personnel, MCPD cannot keep up with the demand for coverage for events like they have in the past. Although officers enjoy being out in the community and participating in events, they are simply needed elsewhere for regular patrols.

Stancliff praised the 6th District officers, noting that even with a personnel shortage, they are still effective in the field. He mentioned the successful recovery of the man who sat on the roof of the Montgomery Village Library, and the apprehension of the three suspects who robbed the CVS earlier in the month. The Commander also gave some brief crime statistics, saying that overall, trends are going down, as compared to last year (stats provided are year-todate [YTD] through the same

He noted the worst change in stats has been Weapon Offenses, which has been a



Campaign letters are prohibited, except for Montgomery Village Foundation and Village homes corporation elections. The views expressed in the Letters to the Editor section are those of the authors of the letters and not necessarily those of the Montgomery Village Foundation (MVF) or its Board of Directors.

2. The *Montgomery Village News* will make every effort to publish all letters

received during the weeks prior to publication that meet the criteria of this policy.

3. All letters (typed, handwritten or e-mailed) must be received no later than 5 p.m. on the Monday prior to publication and distribution for inclusion in the print version; letters received outside this window may appear online in advance of the next printed issue. When a holiday occurs on a deadline Monday, Letters to the Editor must be received no later than noon on the subsequent Tuesday prior to the Friday publication and distribution.

4. Letters must bear the writer's name, address and telephone number for verification purposes. E-mailed letters should contain the subject line "Letter to the Editor." The sole use of pen names, initials or the complete omission of a signature will eliminate

a letter from consideration from publication. A request from the author to withhold the name or mark the letter anonymous will eliminate the letter from consideration.



In Memoriam Rich Wilder

On Saturday, July 30, long-time Village resident and community activist Richard "Rich" Wilder passed away. Rich was a former member of the MVF Committee on the Environment and Transportation, Development and Public Facilities Committee, who worked hard to protect Montgomery Village. Even after serving his time as a member of the committees, he dutifully attended almost all meetings—as well as the Montgomery Village Foundation Board of Directors meetings—to stay informed and share his knowledge and insights.

Rich was also a dedicated member of the Friends of Whetstone Lake (F.O.W.L.), where he inspired Village and area youth to care for their community through cleanup service. On cleanup days, he would often be found rowing around the lake, gathering trash and telling stories. Rich's dedication to the wildlife and environment in the Village helped protect our natural surroundings and keep the community clean for generations of Villagers and wildlife alike.



Rich's passion for the Village was shared with his wife, Jane. The pair fell in love with Montgomery Village after their first visit, bought a home here and were married under one of the infamous gazebos. Together they actively fought projects that would adversely and negatively impact the community, including the proposed M-83 highway. His technical expertise as a scientist at NIST, and his interest in local government, politics and the environment often provided a unique point of view to hot topics in the county and community.

In the summer months, Rich enjoyed the Summers at South Valley Park concert series, and could often be seen in the front row of most concerts. A lover of all types of music, he encouraged others to attend, and even took it upon himself to help clean the paths in South Valley Park to make it easy for residents to get to the music pavilion. Rich was also always on the lookout for a good story for the *Village News*.

Rich's dedication to the Village and the environment, as well as his jovial laugh and commentary at meetings will be missed, but his sentiment will live on.

county-wide problem recently. Stancliff said the majority of the offenses are related to privately manufactured guns from gun kits, or "ghost guns" are they commonly referred to, being out on the street. While the police are making more arrests on weapons offenses, the ghost guns pop up as quickly as the police can shut them down. Lt. Helton noted that the number of handguns has increased; not to registered users, but these self-made handguns by those who are not able to apply for proper permits.

Stancliff answered questions regarding parking enforcement on county roads; increased patrols at Lakeforest Mall; maintenance being performed on commercial vehicles on county roads; and issues with the non-emergency number and 911 service call centers. He asked residents on the call to reach out via e-mail with specific details about the areas in question, so MCPD could take appropriate action. Bid for Watkins Mill Outdoor Fitness Center approved by MVF Board

Since 2019, the Montgomery Village Foundation (MVF) Board of Directors and staff have been working on the repurposing of the previously closed Watkins Mill Pool. The pool was closed due to underutilization and the overhead costs associated to keep it running each year as another pool facility. In February 2020, the MVF Board approved that the site be turned to an outdoor fitness space; staff has been working with KCI Technologies and Montgomery County on plans and permits since.

In the interim, an RFP for the project was released in March 2022, with a return date of June 10. Three bids were received by this time for the project, which includes: the demolition of the existing building and pool facility; necessary site work; installation of required stormwater management facilities; relocation of the existing playground to be adjacent to the outdoor gym; planting of required trees and shrubs; installation of a path network connecting the entrances to the amenities; addition of a 4-foot-high fence around the perimeter of the park; installation of a utilities building; installation of other site furnishings; and the creation of the fitness space, which will include an exercise track, fitness equipment with fabric shade structure, and overhead lighting.

Of the total cost of the project, \$700,000 will be funded via a state bond initiative, secured by Senator Nancy King. The remaining balance will be funded from the Capital Contribution Fund, as this will be an amenity the entire community can enjoy, and may also be used for MVF-sponsored classes.

At the July 28 MVF Board meeting, the Board awarded a bid of \$1,106,223 to Keller Brothers, Inc. for the project. Keller Brothers has performed other work in Montgomery Village, including the Peggy Mark Pool renovation.

Additionally for this project, the Sediment Control plans were approved by Montgomery County De-partment of Permitting Services; a bond for the sediment control permits is required by the county. The Board authorized the EVP to pay the \$16,382 permit bond and fees as related to the Watkins Mill Outdoor Fitness Area project.

OTHER AGENDA ITEMS

Mullis also reported that the annual goose count had recently taken place. The count revealed a total of 551 geese counted in the same locations as counted each year. He said this number fell in the range of normal expectancy, and there were no significant changes in geese population reported.

PRESIDENT'S MESSAGE

MVF Board Vice President Doniele Ayres presided over the meeting in President Scott Dyer's absence. Ayres encouraged any suggestions for the 2023 DRAFT MVF Budget be submitted to the MVF Office, or directed to Executive Vice President (EVP) Dave Humpton.

EVP REPORT

EVP Humpton reported that there had been a lot of recent discussion about security cameras and camera programs. He said East Village was able to arrange a program with RING, and talked about it during a recent Presidents' Council meeting, and the county has expanded their discussions into legislation. He said the chief of police will be developing regulations and information regarding the security camera program. This important tool will help deter and solve crimes.

Humpton also noted that a Public Safety Meeting was held earlier in the week. Sixth District Commander Eric Stancliff discussed issues with staffing and recruitment county-wide; the dedicated MV Team was taken offline for the foreseeable future to compensate for staffing needs elsewhere in the 6th District. Humpton also said that Stancliff's report of crime statistics was overall positive, noting downward trends in

comparison to the same period last year. Stancliff also reported that academy class numbers had declined.

Humpton said the Department of Natural Resources, Land Acquisition and Planning had reviewed the Watkins Mill Recreation Area State Grant and the project would be placed on an upcoming Board of Public Works agenda for approval. It is expected to move forward in August.

TREASURER'S REPORT

MVF CFO Daniel Salazar presented the Treasurer's Report for the year-to-date (YTD) and the month ending June 30, 2022, reporting that overall, all MVF funds were behind budget projections by approximately \$750,000, predominantly from Investment Income (-\$1.2 million). This is offset by Capital Contribution Fees (CCF) which are favorable to the budget by \$117,000, Pool Membership and Fees (up \$52,000) and Camps/ Classes (up \$29,000). Additionally, Salazar said Personnel and Operating costs were lower than expected by \$153,000 and \$78,000, respectively.

Total Revenue through May was reported at \$3.5 million, 23% lower than the budget. Operating Expenses were reported at \$3.8 million, favorable to the budget by 7.2%. CCF was reported at \$179,000 versus the

\$70,000 assumed in the budget; he noted that as of June 30, 90 new units had been sold in Bloom Village.

Salazar said that although Investment Income returned a loss, if this Reserve Fund detail is removed from the picture, the rest of the Operating Fund is highly favorable to the budget.

He said the Balance Sheet continues to reflect MVF's strong financial position with over \$10.1 million of its assets held in Cash and Investments. MVF continues to hold nearly \$3 million in Undesignated Reserves. Assessment Receivables reported an overall decrease from last year of \$223,000, which shows that the collection process is working and payments are being made on time.

The Delinquency Rate for June was reported at 6.3% (534 units), which is lower than both the 5-year average and last year at this time.

NEXT MEETING

The next MVF Board of Directors meeting is scheduled for 7:30 p.m. on Thursday, Aug. 25, as a conference call/Zoom meeting. Dealing with mosquitoes around your home



In the summer months, Village residents spend plenty of time enjoying the parks and paths throughout the Village. One of the most annoying pests we have in this area is the mosquito, which can make an otherwise enjoyable evening relaxing on the deck or playing outside with your children a challenge. Some tips for avoiding mosquito bites can be found at the following link: www.mda.maryland.gov/plantspests/Pages/tips_for_avoiding_ mosquito_bites.aspx.

The Maryland Department of Agriculture, Mosquito Control Program, is responsible for mosquito control in the state, and the Montgomery Village Foundation has signed up for this voluntary program again for 2022. The program consists of larviciding (control of immature stages of the mosquito) and public education.

Mosquitoes are insects that develop through four life stages: egg, larva, pupa and adult. Both male and female adult mosquitoes feed on plant nectar as a food source. Only female mosquitoes feed on blood as a protein source for egg development. In Maryland, there are 62 different species of mosquitoes with around 17 of those species having the greatest abundance and/or impact on human comfort, public health and economic growth. All of these species require stagnant water for breeding and larval development.

The Montgomery Village Foundation has partnered with the Mosquito Control Program since 2003. Technicians were given a map of areas in the Village that could be potential breeding spots for mosquitoes. Every year there is monitoring of these known sites on a threeweek rotation, and if necessary, a larviciding treatment is done according to presence or absence of larvae.

Since this program doesn't take into account private homeowner property, here are some tips for reducing the

breeding spots for mosquitoes in your own backyard.

- Clean rain gutters to allow water to flow freely.
- Remove old tires or drill drainage holes in tires used for playground equipment.
- 3. Store plastic wading pools inside or turn them upside down when not in use.
- 4. Turn over or remove clay pots and plastic containers.
- 5. Dispose of all empty beverage containers, plastic wrappers, discarded toys, etc.
- 6. Check for trapped water in plastic or canvas tarps used to cover boats, pools, etc. Arrange the tarp to drain the water.
- 7. Pump out bilges in boats. Turn canoes and small boats upside down for storage.
- 8. Replace water in bird baths at least twice a week.
- 9. Remove pet food and water dishes that are not being used.
- 10. Flush livestock water troughs twice a week.
- 11. Don't leave garbage can lids lying upside down. Be sure water does not collect in the bottom of garbage cans.
- 12. Flush water in the bottom of plant holders twice a week.
- 13. Fix dripping outside water faucets.
- 14. Turn wheelbarrows upside down when stored outside.
- 15. Check around construction sites or do-it-yourself improvements to ensure that proper backfilling and grading prevent drainage problems.
- 16. Check ornamental ponds, tree holes and water-holding low areas for mosquito larvae.

Call the nearest Mosquito Control Office (see below) if you find, or suspect, mosquito larvae are present.

17. If ditches do not flow and contain stagnant water for one week or longer, they can produce large numbers of mosquitoes. Report such conditions to a Mosquito Control Office. Do not attempt to clear these ditches because they may be protected by wetland regulations.

ing finalized, and based on this, the proposed assessment rates may change.

The Audit Committee will review the Draft Budget at their Tuesday, Aug. 16 meeting, before sending it to the MVF Board of Directors. The MVF Board will then review the Draft Budget at their Thursday, Aug. 25 meeting, with the goal of approving it for publication. Once published, the budget will be open for a formal public comment (30 days) and subject to further revisions before its final approval in October. 

IN THE NEWS

Please pick up after your pets and other pet reminders



The Montgomery County Department of Environmental Protection reminds all residents that picking up after their pets is not just a matter of public health and safety, it's also the law. And with more residents working from home and able to enjoy the outdoors walking their pets, there has been an increase in pet waste left on the ground in the past year.

Did you know a typical 40-pound dog produces 274 pounds of waste per year? Pet waste is dangerous to your health. It's more than just a nuisance—it is considered raw sewage and can contain

harmful bacteria and parasites. When it's tracked into your home, it can make you, your family and even your pets sick.

Pet waste also pollutes our waterways. Every time it rains, thousands of pounds of pet waste left on the ground flow into storm drains that empty into Montgomery County streams. These streams contribute to drinking water and empty into the Chesapeake Bay. Every pet owner plays a part in keeping our water clean. Pet owners who do not properly dispose of pet waste may be subject to fines for each offense.

PICK UP AFTER YOUR PET!

Responsible pet owners pick up after their pets, both at home and on public land. Carry bags and pick up pet waste whether on walks, in your yard, or in the park. Dispose of pet waste in a trash can. Do not place the bag in a storm drain or leave it on the ground.

In Montgomery Village, many local associations have installed pet waste stations along popular walking routes. The stations contain waste bags and a receptacle to put it in. If they are full, owners should carry waste with them and dispose of properly at home.

There are a number of other animal control laws on the books in Montgomery County, including "At Large" (leash laws), "Unwanted Contact" and "Dangerous Animals" – see below for a quick summary.

AT LARGE

Any dog is at large if it is outside the owner's premises and not leashed, unless it is a service dog, is in a dog exercise area designated by the Maryland National Capital Park and Planning Commission, or is participating in an approved activity.

Any other animal (i.e. unaltered cat, livestock animal) is at large if it is outside the owner's premises and not leashed or immediately responsive to verbal or non-verbal direction.

The common area of a homeowner's association, condominium or cooperative is not the owner's premises.

Unwanted Contact: The pet owner must prevent unwelcome or unsolicited threatening physical contact or close proximity to a person or a domestic animal that occurs outside the owner's property that may cause alarm in a reasonable person, such as biting, chasing, tracking, inhibiting movement, or jumping.

DANGEROUS ANIMALS

An animal is deemed to be potentially dangerous if it has inflicted a bite on a person either on public or private real property or has killed or inflicted severe injury to a domestic animal when not on the owner's property or has attacked without provocation. An animal which has been declared to be potentially dangerous and subsequently engages in one of these behaviors again will then be deemed to be dangerous.

A person may not possess any wild animal or any animal that has been declared to be dangerous. An animal is deemed to be dangerous if it has without provocation killed or inflicted severe injury on a person; if it poses a physical threat to humans because of specific training or demonstrated behavior; or if its bite is poisonous.

Animals which have been deemed to be dangerous must be kept confined in a secure enclosure to prevent direct contact with humans or other animals, and must be leashed and muzzled, and under the control of a person at least 18 years old who is physically able to restrain the animal any time it is removed from the owner's property.

Local leaders honored for distinguished service in education

On May 12 the Montgomery County Board of Education held its 25th Annual Award Ceremony for Distinguished Service to Public Education, honoring individuals, groups and organizations that make exemplary contributions to public education in the county. This year, two individuals from Watkins Mill High School (WMHS) were honored for their dedication to students.

Clarence McNeary, a WMHS alumnus, was honored in the Community Individual category. McNeary serves as a youth development specialist at WMHS Wellness Center. He strives to provide positive youth development and services to more than 100 students each year. McNeary implemented curriculumbased programs such as goal setting, leadership and Black male empowerment, and has played a vital role in the student ambassador program that provides stipend for students to take leadership roles in food insecurity and vaccination clinic outreach.

McNeary was the original director of a food distribution site at Montgomery Village Middle School, serving over 500 residents each week, and providing outreach services. He continues these roles at his alma mater, as well as coaching football, and coaches the Excel

Beyond the Bell program at Montgomery Village and Forest Oak middle schools.

Sharon Faber, WMHS ESOL and Theater teacher, was honored in the MCPS Staff category. When Faber began teaching at WMHS in 2016, she created the first-ever theater course designed for new immigrants to the county. She developed a full-year arts elective curriculum for ESOL students. This class quickly gained popularity became a "must-take" for 9th and 10th graders for the social-emotional skills the class promotes in preparation for college and career readiness. Area theaters collaborate with Faber to bring real-world experiences to multilingual learners, at no cost to the school or students.

In the last 6 years, Faber has been able to uplift and expose nearly 600 English language learners to the innovative theater program, creating a sense of community and safe space for immigrant youth to share their stories and feel welcome.

Congratulations to Mr. McNeary and Ms. Faber on their recent accolades and their dedication to the community through education. WMHS and the Montgomery Village community are proud of how you impact the lives of students!







STEDWICK SIGNALS

It's all about trees

KEEPING STEDWICK GREEN

Stedwick would not be the lovely and inviting community it is without our spacious landscaped areas and the adjacent woodlands throughout the area. The board of directors is aware of the value of our "natural" spaces and so a sizable portion of your assessments go towards the upkeep and improvements made yearly to our green spaces. As the area matures, so do the trees. Currently, we are losing more trees than in previous years, and with an associated cost.

In 2016, the Department of Environmental Protection and Montgomery County signed an agreement for the county to plant and maintain trees with the sole focus of planting shade trees. Stedwick has applied for, and twice benefited from this agreement; one year receiving 47 and a second year receiving 49 trees. These trees were planted in areas chosen by the maintenance committee. We had only to water the trees as needed the first few years. We have applied for consideration again this year and are awaiting a response.

Stedwick also plants mature trees to the extent possible within the budget. In 2020, we planted 25 mature trees spread throughout the community. In

that year we also planted 120 small trees – 1 to 1-1/2" caliper ones – which we used to fill in open areas where larger trees once grew. They are not very visible now, but if they survive, they will be the canopy of the future. In 2020, we had an exceptional opportunity as J.B. Kline Landscaping and Lawn Maintenance Company had trees left over from another large project and offered them to Stedwick. Our only cost was the planting, easing our budget and giving the tree population a major boost. Like all plants, trees do not always meet their full potential so the need to keep planting will always be with us.

TREES ARE AN ASSET

The existing trees in Stedwick are among our most important assets. They are a capital item of significant value and thus included as a line item in our reserves budget. Our trees and shrubs have value beyond their beautifying qualities as they provide shade, protection from winds, help control urban storm water runoff, and produce oxygen while absorbing carbon dioxide, a major greenhouse gas.

Trees can also be a stimulus to economic development, attracting new business and people looking for a home in beautifully landscaped area. Commercial retail areas are more attractive to shoppers,

apartments rent more quickly, tenants stay longer, and space in a wooded area is more valuable to sell or rent.

The USDA Forest Service notes trees placed properly around buildings can reduce air conditioning needs by 30% and can save 30 to 50% in energy used for heating.

Dr. E. Greg McPherson of the Center for Urban Forest Research says if you plant a tree today on the west side of your home, in 5 years your energy bills should be 3% less. In 15 years, the savings will be nearly 12%.

TREE MAINTENANCE

Given the importance of the trees as assets and a main element in the beauty of the area, the board of directors keeps close tabs on the needs of trees. Our trees are subject to stress from storms, excessive amounts or lack of water, compacted soils, air pollution and the straightforward process of aging thus requiring constant attention and resources. Ongoing efforts to maintain trees and shrubs include a pruning schedule that ensures each neighborhood is trimmed every 3 to 5 years. Unfortunately, the pandemic impacted our normal schedule for 2 years, but we are now back on track with pruning. Every month, with information gleaned from our maintenance inspection tours, we add dying or dead

specimens to our Tree Removal List and for a prompt removal. Trees that appear unhealthy or otherwise compromised are put on a Tree Watch list. Residents also help the process by alerting the community manager of trees in need of attention.

TREE DISEASES

Today, many of North America's trees are being destroyed by non-native insects and diseases. These invaders are removing entire species of trees from our forests and neighborhoods. The latest of these invaders is the Hypoxylon Canker which is a fungus attacking all species of oak. Thus far we have removed 3 diseased oaks from Clusters I and expect there will be further need as the fungus can quickly colonize weakened or stressed trees growing nearby.

In the past, we dealt with Emerald Ash Borer that was causing removal of our ash trees; dogwoods have succumbed to anthracnose, a disease which is less common now, but Powdery Mildew has become the most serious threat to these trees. While no longer an issue, the so-called Dutch Elm Disease sharply reduced the American Elm population throughout the country. All tree diseases cost money for treatment, removal and replacement. Tree diseases will always be with us, and Stedwick will continue to respond to diseased trees as much as possible within the confines of our budget.

Summer updates

by the Northgate Board of Directors

A number of projects throughout the community have taken place or will shortly. Over \$10,000 in storm drain repairs were done on Maple Leaf Court, Maple Leaf Drive and Brookridge Court; asphalt repairs and crack fill in Overlea were completed at a cost of \$41,500; additional asphalt repairs in Dorsey's Regard, McKendree I & II and Shadow Oak

cost \$145,000, and an additional \$80,000 in crack fill should be completed by the end of the year. There is a minimum of \$30,000 in tree work that needs to be done in the fall.

The board watches the budget carefully. Like each of you, we have to deal with increasing costs. Our trash company raised its price by \$1 per unit effective July 1, adding an unexpected \$7,000 to the community's costs. It remains the best option

both cost and service-wise, but will add a minimum of close to \$14,000 to the FY23 budget.

The board will begin its FY23 budget work in August. The community will be kept informed.

Please put a lid on it!

New signs were recently installed in some North Village neighborhoods reminding residents of the need to place trash in lidded cans. This is Montgomery County law. Lidded cans prevent problems where rodents, crows and other animals are rummaging through plastic trash bags. According to the county health department, vermin is a growing problem in the county. Plastic trash bags on the ground contribute to infestation. This issue requires the cooperation and effort of all our residents, and each resident is strongly recommended to follow proper storage and garbage disposal rules.

Note: only one trash pickup day for Labor Day week

On holiday weeks, J&J will pick up only once that week. Trash will not be picked up on the holidays shown below. If the holiday falls on a Monday, then the pickup will be



on Thursday. The days with an asterisk (*) indicate that the county transfer facility is closed, so recycling will move one day that week.

DON'T DUMP THAT STUFF!

Bulk trash costs everyone money. We ask everyone's help with the amount of bulk trash in the common areas (a.k.a. dumping large household material). Every time a special call must

be made to our special vendor to pick up the bulk trash, we must pay for that separately. Ultimately, the "we" is all of us in North Village. If you see neighbors putting out bulk trash, please ask that they call for one of their free bulk pickups if they haven't already. If you see a neighbor that is dumping, you may e-mail our community manager so that we can get a letter out to them.

2023 BUDGET IN PROCESS

We are now working on the 2023 budget with the information from security, trash and the management agreement with Montgomery Village Foundation recently arriving. As suspected both the security and trash contracts have shown an increase over last year. The 9% CPI increase is putting financial pressure on the community boards budgets for 2023. We will do whatever we can to minimize the increases. We can only do so much

with the types of services we need especially as the vendors struggle to find labor. We will be finalizing and approving the budget at the August meeting.

MOWING SCHEDULE AND LEAF REMOVAL

Our landscaping company, BrightView, is scheduled to mow common areas in North Village until November. Please note that Montgomery County is no longer allowing pesticides to be used in grass applications. This means you will see more weeds mixed in grassy areas. Note that we have two leaf removal pickups scheduled this fall. Please understand that only the week the signs are posted are you allowed to put leaves on the street. Otherwise, please bag the leaves for weekly recycling or have your contractor remove the leaves entirely. Also, a question arose regarding composting. You can bring your composting to the MV Farmers' Market at Christ the Servant Lutheran Church, 9801 Centerway Road, on Saturdays. For more information, visit www.mvfarmers market.com.



WHETSTONE WATCH

Maintenance items in Whetstone

by the Whetstone Board of Directors

In the last several months, and months to come, Whetstone residents are seeing a wide variety of maintenance activity underway. Everything from pressure washing entrance signs, milling the lakeshore path and general landscaping, to large-scale projects such as street repaving and major work on our aging trees.

NEW POST LIGHTS

The board approved the replacement of all 400+ globe post light fixtures and posts for every existing lighting unit in the Whetstone community. The approved fixture is the Wave Lighting model 410-LE26, color black, with beveled Itenses. Posts will be black fiberglass, standard 3" diameter, mounted in a concrete base. A sample can be seen at the driveway entrance to North Shore Dock. These fixtures use standard replaceable screw-in A19/E26 bulbs. Bulbs are included with installation; presently an 800 Lumen, 90 CRI, 3000 Kelvin, 10 Watt frosted LED.

All this jargon demonstrates how confusing buying light bulbs has become for many of us. Gone are the days of incandescent bulbs, when all you needed to know was basically wattage. Wattage is actually how much electrical power a bulb uses, not necessarily brightness. Since LED's use significantly less power, we need to switch our thinking to the actual measurement of brightness, Lumens. An 800 Lumen LED bulb is roughly the brightness of a 60-watt incandescent bulb, yet uses less than 10 watts of electricity. Next time you're at the hardware store, look at the specifications on bulb boxes, or maybe a conversion chart online, you'll be saying lumens before you know it.

The CRI rating is the "Color Rendering Index," which simply rates how accurately and cleanly a LED bulb produces light for its indicated color/temperature (anything 90 CRI and up is good). This brings us to the aforementioned color/temperature, which is measured in Kelvins. Kelvins rating refers to how warm (amber) to cool (blue) the light

is. Most bulbs are available in the 2700K to 6000K range; high numbers will appear blueish, and lower numbers amberish. When in doubt, a 3000K bulb is usually the happy middle ground, and most similar to color of our old incandescents.

And finally, to anyone wondering what the A19/E26 specification means: A19 is bulb size (19 one-eighths of an inch wide), and E26 is its type of screw-in base. In this case E26 is the standard base we have in most of our household lamps.

Formal scheduling of our post light replacement project is currently pending, as supply chain issues are being assessed. Presently, we hope to begin sometime later this fall. And we will provide ample notice to all residents, as installation will require working access to the area around your existing light pole.

STREET REPAVING

As you read this, much of our street repaying should be well underway, weather permitting. A letter describing the schedule, with a map indicating phases and affected streets, was mailed to residents the last week of July; this document is also available on our web page at www.montgomery village.com. The small streets will be worked on between Monday, Aug. 1 and Friday, Aug. 5. Whetstone Circle will be milled on the Saturday, Aug. 6, then paved on Monday, Aug. 8.

We greatly appreciate everyone's patience with this somewhat disruptive project, but when it's complete we'll have significantly improved the appearance and quality of our streets, which makes a big difference in the value of our already wonderful neighborhood.

TREE MAINTENANCE

Everyone's certainly aware we were very busy this spring with major tree maintenance and removal. A big thank you to our residents for contending with the noise and general disruption. To anyone concerned, we're certainly not planning on removing all our wonderful big trees, but unfortunately due to age and disease, a certain number of our old Oak and Gum trees were inspected

by our certified arborists last year, and deemed in need of removal. That work was completed this Spring.

Following this, we recently learned there are 13 additional trees in bad shape, with a recommendation for removed as well. Removal of these additional trees was discussed at the July 14, 2022 board meeting. We will be replacing most of what was removed with new Zelkova trees (2 ½" to 3" trunk size).

HOMES CORPORATIONS CALL FOR CANDIDATES

Volunteers needed for homes corporation boards of directors

Each year, the Village homes corporations seek candidates for election to their boards of directors. Interested residents are invited to submit applications for candidacy to the Nominating Committee of their local homes corporation.

Directors of homes corporations are responsible for setting assessments and managing the maintenance of all open spaces, streets, paths and lights that belong to the individual homes corporation.

Basic qualifications for board membership are time and interest, but whatever other knowledge, training, skills or experience one has will almost certainly be used in some capacity.

1. According to the documents, a candidate is not required to be a resident of Montgomery Village, except in Whetstone Homes Corporation and North Village Homes Corporation, where the candidate is required to be a resident homeowner. However, resident candidates must be in good standing with the Montgomery Village Foundation and their respective homes corporation with regard to covenants and policies and must be current in all assessment payments. In

several cases, the Nominating Committee is given the authority to determine which of the nominees will be on the final slate of candidates.

2. To apply for candidacy, a prepared statement of the applicant's qualifications and interests must be delivered to any member of the Nominating Committee or to the Montgomery Village Foundation office, 10120 Apple Ridge Road, no later than 5 p.m. on the closing dates stated in the box.

3. A candidate may be solicited or may volunteer. A resident nominating another resident must secure his/her written consent.

4. The number of candidates is unlimited.

5. All nominees will be requested to submit a single page (typewritten, double spaced) statement, which will be reproduced in the December, January or February issue of the *Village News* and will be sent to all voters along with the ballots (standard form will be supplied to board nominees).

6. Also, per a new Montgomery County Law, effective January 1, 2016, if elected, candidates must participate in a Montgomery County Commission on Common Ownership Communities (CCOC)-ap-

proved board member training class, to be scheduled and completed within 90 days of the start of their term of service.

Ballots will be mailed to the electorate either in December, January or February, depending on the specific corporation's election calendar.

In addition to electing directors, each homes corporation also elects a representative and an alternate representative to the MVF for one-year terms. Suggested names for the position will appear on the ballots.

Each board of directors consists of nine directors who serve three-year terms. The terms are staggered, creating three vacancies every year.

Note: While the word count for candidates' statements varies among homes corporations (check with your community manager), the word count for candidates' statements for the *Montgomery* Village News must not exceed 200 words per candidate.
